Message from the President

Dear ASHA Members:

2008 Election and vote counting procedures


- 1) Candidate contact information and their responses to a set of questions regarding board positions and ASHA are included in this bulletin.
- 2) The Secretary prepares the notice of the election and the ballot which contains the full text of any matter to be voted on and an alphabetical list of the names of all eligible candidates for the board of directors (by last name). The election notice contains instructions and the deadline for the return of ballots, which is not less than 30 days after the date of mailing of the notice and ballot.
- 3) The Secretary mails the election notice and ballot to each member eligible to vote on the matter(s) in the election (as defined in the by laws). Copies of the mailing list are sent to the election clerk (notary), who will be counting the votes to check against the ballots received and to the Chair of the Nominating Committee.
 - a. The mailing also contains the return envelope addressed to the election clerk/notary for the completed ballots.
 - b. The back of the ballot return envelope must be signed by the voter(s), so that the signature crosses the sealed flap of the envelope in order for the enclosed ballot to be counted. If more than one voting member resides in a household, all ballots may be returned in one envelope, as long as all voter's signatures are on the back of the envelope. If the signature is hard to read, the name must be printed underneath the signature.

c. Anyone not wishing to have their legal signature on the back of the mailing envelope may seal their ballot in a smaller envelope, sign over the sealed flap as described above, mark the envelope as 'Ballot' and mail it in the return envelope provided by ASHA.

- Completed ballots are mailed directly to the election clerk/notary via the addressed envelope included with the election notice and ballot.
- 5) One week after the election deadline stated in the notice, the election clerk/notary and 2 or 3 assistants, who are selected by the notary and have no connection with ASHA, will check the postmark dates and the signatures on the envelopes against the list provided by the secretary. Ballot envelopes with any of the following will not be counted, except as indicated:
 - a. Postmarked after the deadline date. Envelopes will be set aside unopened.
 - b. No signature on the envelope clerk will open these envelopes to check for an enclosed envelope with signature or a signature on the ballot. If there is a valid signature on an enclosed envelope or on the ballot, it will be counted, if not it will not be counted.
 - c. Signature on the envelope/ballot does not cross check with the mailing list. These envelopes will be set aside unopened.
 - d. More ballots in the envelope than there are signatures on the outside. The clerk will check the ballots to see if all voting is the same. If it is, one ballot will be counted for each signature. If the voting is different on the ballots, none of the ballots can be counted since there

is no way to know which ballot belongs to a signature.

- 6) The election clerk/notary and assistants then open all valid envelopes, separating the ballot(s) into one container and the empty envelopes into another container. The ballots are then counted and the count is verified. The notary writes up a statement of the election results, notarizes it and returns it to the office with all ballots and envelopes. (All envelopes and ballots are kept in the office for two years.)
- 7) The Secretary shall immediately notify the Nominating Committee Chair and the President of the results. The Chair shall then notify the committee, the candidates and the board members of the results as soon as possible.
- 8) The Results must not be released to anyone else until December 21st or until all of the above have been notified, which ever comes first.
- 9) In the event of a tie, the Nominating Committee Chair will notify the candidates involved. If one wishes to withdraw, the other shall be the new board member. If both wish to continue, their names shall be placed in a container and a Notary Public shall draw the name of the winner.
- **10)** The new board members will be announced in the winter newsletter.

Energy and finances previously dedicated to showing my Shires will be shifted to an administrative capacity by committing these resources to ASHA BOD service.

Since 2002 I have purchased six ASHA registered stallions and geldings and have shown them at Regional and National Shire shows from 2003 through 2007. I have owned a total of seven Shires but currently have five. My gelding Bentley claimed National Reserve Champion gelding honors in 2005 and has since claimed considerable success as a hitch horse. The exhibition platform of ASHA-sanctioned shows is one that I heartily endorse as I believe it to be the most vigorous and influential for showcasing the Shire's unparalleled curb appeal, as is the venue of industryesteemed draft horse shows in which I also participate. Since 2005, I have shown at every National Shire Show in support of my breed organization and plan to continue along this rewarding path.

Given that the pulse and vivacity of any breed association is riveted by its membership, I personally subscribe to the principle that optimism and confidence among the members equates to an organization with drive and vitality, as well as one with ample financial resources. That stated, my grave concern over the growing numbers of ASHA members falling away from our association to join the ranks of 'former members' is a compelling basis for carefully reviewing member benefits: what are they? Why are resounding numbers of members migrating toward an almost exclusive SHS registration and membership as if it is the only remaining and bona fide breed registry for Shires even on US soil? At the very least, our association should see higher numbers of dual-registered horses, and I believe it would if there were distinct and exclusive benefits to being a member and registering horses with ASHA. One of the current practices I am eager to amend is that of optional memberships. It is illogical and detrimental to the ASHA as well as particularly dispiriting to our paying members that non-members realize many of the same benefits that others are paying for. An example of this would include exhibiting horses in our ASHA Regional and National Shows.

In 2004 and 2005 I served for approximately eighteen months as ASHA Editor, and during and since that time I have regularly contributed articles and photos to the Shire Magazine as well as to other draft horse publications in support of the American Shire. Additionally, I travelled to Peterborough England in 2007 to visit the National Shire Show as well as to chronicle that event and present it to our ASHA membership. I have also invested time and photos to update the online studbook. In 2007 I helped set up the education day at Black Forest Shires by providing my geldings for the judging seminar. I have maintained active membership since joining and purchasing my first Shires in 2002. I have attended Regional and National Shows since acquiring my Shires and try to attend at least two Regional Shows as well as the National Western Stock Show in Denver each year, so the bulk of my activity is heavily weighted in publicly showcasing my Shires in dual capacities: open class and ASHA sanctioned events. Additionally, I have participated in two national meetings/education days.

As the world around us continues to change, the ASHA must also adapt and employ positive rationale, resourcefulness, and versatility in order to survive. Member dedication and participation must be rejuvenated since they are part and parcel of generating sufficient revenue. I listen closely to members, so what I present here is a resonance of member concern. Our morale and our budget remain heavily mired by the aftershock of the lawsuit, something we must get behind us as soon as possible. Investigating ways to save money may par the significance of generating additional revenue. I believe that a paramount mission for us is to pay off the lawsuit so that we can more quickly revive and restore membership ambition.

ASHA membership must offer remuneration if we are to expect growth. A recurring theme of disgruntlement among paying members is that of allowing non-members to participate in ASHA events such as shows. Another issue is that of the exorbitant cost of travel to attend Regional Shire shows. As fuel costs continue to stifle us, the need to graft our point system onto existing shows such as Jordan, MN, the Calgary Stampede, and Denver's National Western Stock Show, among others, become more realistic and certainly offer to more steadily and equitably poise our current point system.

Thirdly, some of our ASHA by-laws and rules are very vague and are consequently open to varying degrees of interpretation. A more circumspect approach to pruning and updating our rules and by-laws is both wise and advantageous, as is the need to be sure that the membership understands the full scope of any given rule or set of rules. I am very hesitant to cite infractions against members when our rules allow for the very actions that some condemn. In this light I am inclined to follow the lead of other successful draft horse organizations in resolving these incongruities and maintaining a level, welcoming playing field.

I would like to see ASHA mend some of the bad feelings with those of our membership lost with the extra fees that were imposed due to the financial hardship placed on ASHA.

Those that have stuck with ASHA and continue to support this organization should be very proud as ASHA would not be in existence today without them. THANK YOU!

I have been an active member of ASHA for the last ten years. During most of this time I have been the webmaster for the ASHA shirehorse.org site. This work has included implementing our online studbook, online point system management, online show results and entry program, etc. I am a dedicated Shire lover. I will continue to own Shires for us long as I am physically capable of doing so. All of my horses are registered with ASHA. As far as strengths that I bring to ASHA, I believe that I am open minded and listen to everyone's opinions. I'm a good team player and I have worked well with the rest of the BOD's during the last four years that I have been on the BOD.

Promote the Shire. Thanks to the hard work of some of our members, Shires are getting maximum public exposure, such as those now working in Disneyland and those representing the breed at Breyerfest. Equine Affair is a huge event and introduces thousands of horse lovers to Shires. Even with the ASHA finances as tight as they are, we can't stop supporting these types of events.

Continue to build our membership. We lost a significant number of our membership directly due to the lawsuit we were forced to pay. Now we need to build on those that have stuck through the hard times with ASHA.

Build up ASHA finances so we will have the means to offer more incentive to get horses to the shows and other equine events that will get quality Shires in front of the public.

Personal Goals:

- Continue my work on a world wide on-line Shire studbook; today the online studbook is limited to just ASHA registered horses. We are close to adding the CSHA registered horses and still trying to get the SHS studbook
- Continue to support the ASHA point system; I believe the point system can be used to help build our membership and encourage owners to get their horses to the shows. Right now the point system is

limited to halter classes. Let's add performance points for members of ASHA and horses registered with ASHA for both hitch and riding classes. with ASHA for both hitch and riding classes.

Retired professional experienced with education, audit and breed organizations, and have retired my hitch horses in order to dedicate my time to the ASHA.

I have been very active in the ASHA promoting Shires by competing with my registered six-up hitch in Regional Shire shows and open draft horse shows alike. I bought the National Grand Champion stallion in 2001 which I eventually stood to some very quality mares that I acquired over the next few years. I currently own four grade Shires. I served as administrative secretary for a brief stint just prior to the explosion of strife for this organization which at the time was one of the most potentially obliterating events I've ever witnessed. After careful consideration, the unabashed hostility of the 'players' in this war was the impetus for my resignation at that time. Now that the issue has run its course and certain players are removed from the BOD, I am very eager to aid the ASHA in modifying our by-laws so that we are never again caught in the debilitating effects of such ridiculous and sacrificial fighting. The most important undertaking we face and one that I believe we must satisfy with immediacy is that of the lawsuit. We can never hope to move forward with the aspiration, determination, and purpose that any successful organization requires unless we get this behind us forever and employ wise and guarded measures to be certain it never happens again.

The core of my ASHA participation is rooted in the exhibition and breeding of my Shires. At all times though, I have been very keen on association developments, especially in the aftermath of the lawsuit. Benefits and services that I have utilized were mainly in the form of registrations and transfers, but I certainly enjoyed the occasional quality articles in the Shire magazine as well.

There is no question that, paramount to the survival of the ASHA, the budget is on unstable ground and must be carefully and rigorously monitored. Also at the heart of ASHA challenges is that of membership and Shire horse numbers. I'd like to see ASHA membership mandated the way other successful breed organizations have done. It's sensible, it's fair, and it works. If you play, you pay. It's ludicrous and defeating that some non-member show participants line their horses up next to dedicated and paying ASHA members while they haven't contributed at least membership dues. Further augmenting this blunder is then seeing the benefit of their animals listed in the point system which is also funded by our membership. The practice of what many members including myself view as preferential treatment of non-members must come to a halt. A third issue that remains consistently bothersome to me is the misinterpretation of certain rules. I do not believe that the vast majority of the membership understand what certain provisions within, say, the show rules actually represent, and after a show, members and BOD members alike are up in arms over resulting member actions. If the rules and by-laws remain 'grey,' they are open to challenge and at the very least, misinterpretation. A revamping is in order and would insure us against future problems.

A few months ago I was at a cross-roads: should I delve into more Shire purchases, or, dedicate my energy and talents to serving ASHA?

Both of my Shire horses have won numerous national and regional titles. For most of my driving career, I have remained undefeated, winning back to back national ladies cart titles with my gelding, Willie. Over the next two years I will be adding to the 2 Shires I currently own, but for the time being I am dedicating most of my time to the ASHA on an administrative level. I would love to see the ASHA emerge stronger and more financially solvent than ever before, but we have our work cut out for us in order to accomplish that. One of the goals I personally would like to see is that of an American Stallion inspection process. With such critically low numbers of Shires in this country, I am quite disturbed that so many of these horses are of very poor quality, a detail that raises another red flag where breed survival is key. I also believe that it is in the best interest of the ASHA to align ourselves with the majority of the draft horse industry. In that light I feel strongly that our point system should include open draft horse shows since an isolated point accumulation is not nearly as valuable as one tallied amidst the larger and more widely respected shows. We promote and campaign the Shire more effectively and impressively by presenting this horse to the entire world, not just among ourselves.

I am a practicing veterinarian and have been an active member of several breed organizations including that of the ASHA. I believe that my affiliation with other breed associations coupled with my veterinary skills could certainly be applied to stallion inspection development, something that I have already spent time discussing with fellow SHS members in England. Regarding ASHA involvement, I have always participated in regional and national Shire shows and last year sponsored the national champion gelding award. I am a firm believer that merit is most appropriately bestowed on those who get their Shires into the public eye by venue of draft horse shows.

Having experience with other very successful breed organizations, I definitely see the need for requiring ASHA membership for anyone participating in Regional and National Shire shows. I would also like to see a benefit for those individuals who dual register their Shires in both SHS and ASHA; doing so supports the recognized breed association on our home turf. The second issue is that of our budget woes. How do we generate growth and nourish our frail finances in the aftermath of the lawsuit? Can bylaws and rules be tidied up to secure this association's resilience to any future litigation? I believe there is much we can do to protect ourselves by tackling some rather ambiguous by-laws and rules. Thirdly, I'd like to see the ASHA mentored by perhaps an outside draft horse organization such as the Clydesdale Breeders of America. What practices do they employ that make them successful with such things as a world show, registrations, finances, etc?

I have and will continue to attend annual meetings and otherwise fulfill my responsibilities as a Board member.

We currently own a Shire stallion, three mares and assorted offspring using the prefix Rice Creek Shires. I currently serve as President of your organization and I am a candidate for my second term on the Board.

I would like to see ASHA continue its strong support of regional and national shows. We have instituted a rotating national show that has provided a national show opportunity for the whole country. I would hope that as our marketing efforts continue we can develop more regional shows and ultimately more venues.

Another significant goal is to increase ASHA's commitment to equine related trade shows and fairs. Thousands upon thousands of people, who are already interested in horses, have made the effort and paid the entrance fee to view various breeds. Shires can be very successful in this competitive environment but we need to make this investment on a broader scale.

Rice Creek Shires supports ASHA in many different ways. For example, it is our practice that if we sell or transfer a horse we will purchase the buyer a one-year membership in ASHA if they are not already a member.

I have been privileged to serve as president of your organization. I am most proud of the accomplishments my fellow board members have made to conduct ASHA operations in a businesslike manner. Their willingness to listen to each other and try and find a common ground has resulted in significant progress in ASHA's business.

The three ASHA issues that I consider to be most important in the next four years are marketing, finance, and increasing the number of registered horses.

Marketing: As in most business, growth is a critical component of success. We have a unique product in this breed. Like any other business however we need to expand upon our efforts so that people become more familiar with Shires. Finance: There is no benefit to rehashing our challenging recent past but it is very heartening to see our current financial picture showing substantial improvement. Marketing cannot be done without a sound financial base. Heinz Naef's agreement to spearhead a Shire horse foundation and his successes in raising the initial funds to begin that process will provide another opportunity for financial success of your organization. We want to attract and encourage members who will look for opportunities to financially support your organization and recognize that its viability makes their investment in Shires even more valuable.

Increasing Registration Numbers: Although certainly marketing a product for which demand exceeds supply is advantageous in the short run, in the long run we need to increase our registration numbers so that our breed can take advantage of the marketing opportunities available to us.

Of course not everyone can be or should breed Shires but if we continue to make financial progress that in turn supports our marketing opportunities we will need to increase the number of registered horses available for purchase. If we are able to do that the potential exists to substantially increase our breed popularity and of course the American Shire Horse Association.

In closing I would thank each and every one of our members for the opportunity to have served on your board and I will look forward to opportunities for service as the future may hold.

I plan to continue supporting ASHA through committee work and upon election I plan to attend the necessary meetings to fulfill my board duties.

I've been breeding Shires for 14 years and joined ASHA six years ago. I joined for a number of reasons as being an overseas member of England's Shire Society wasn't fulfilling the personal involvement I wanted to actively take in promoting the breed.

I am the show coordinator for the MN Regional of which this will be my fifth year. I played an active role in starting the first show back in 2004. I also assisted in making ASHA's Selection of a Shire Horse – Conformation video by preparing and decorating the horses used for footage. I have attended ASHA's annual meeting. I also played a large part in implementing the Premier Points system and in creating the first Shire Futurity of which will roll out next year.

Our farm, known as Haugen-Hill, is where eight Shires make their home. My main goal is breeding, but we also show, train, and offer the occasional Shire for sale. I also take an active role in our county's 4-H where I judge and make our horses available for youth to exhibit in the horse-less horse project. I also promote Shires in our area by attending parades and expos. Of my accomplishments, I feel the breeding program I've established has helped me excel in the show ring and also in marketing my horses. My goal is quality, not quantity. My husband and I have recently built a horse barn where we'd like to bring collection services in-house for outside draft stallions as it is hard to find facilities within our area that provide these services.

I hope to help ASHA in regaining its status and becoming a premier association among the draft breeds. Whether it is through changing our usual way of business or implementing new ideas to gain more membership and enthusiasm, I plan to help educate and promote others of ASHA. I am also an advocate for stallion inspection and would welcome a program that selects superior males for breeding use. I know it is cold in February in MN, but hope to host an annual meeting/Education Day in the future.

I feel I can bring several different qualities to the Board. Not only do I own and operate my own small breeding farm, but I also work a full-time job. I feel that I have excellent organizational skills as well as have the ability to stay focused. I feel these two qualities are very important in running meetings. I also feel that my training as a manager can help facilitate meetings as well as re-direct discussions that get off topic. I feel that through my college education I've got a good understanding and background of math and accounting to aid in financial decisions. In owning your own business these tools are put into effect on a daily basis. For me, I welcome implementing a stallion inspection in which superior male breeding prospects are selected. I feel this would help facilitate breeding only quality animals in the US. It would also help the US in exporting their Shires to other countries. I would help promote this policy in getting my breeding stock inspected as well as breeding to other approved animals.

I also feel that membership needs to be stronger in regards to enthusiasm and also in total numbers. This will also help with revenue coming into the association. Each time I sell an animal I educate people about ASHA and tell them the benefits of belonging to the association. In addition, I feel that communication among Board and members is very important. In the past I've felt as a member that boards have worked in secretive ways and that communication to us as members has been limited. I am semi-retired and have the time and commitment to attend board meetings and participate in committees. I have sufficient financial resources for travel expenses.

Together with my wife, we have raised Shires for more than fifteen years at our farm called Sudden Creek Shires. We started with two grade fillies. Since that time we have developed and maintained a herd of approximately 35 registered horses. Currently our herd is comprised of fourteen senior mares, ten junior fillies, one stud and ten geldings. In 2008, we had seven foals; in 2009, we expect to have twelve.

In addition to breeding, we have shown our horses in both the regional and national Shire shows. (When possible we also participate in local fairs and expositions.) We have exhibited in both halter and hitch classes. Our largest hitch is four-horse.

In 2006, we were proud when our junior mare received National Reserve Grand Champion at the national show in Columbus. Additionally, our unicorn hitch placed first at the same show.

We work continuously to improve both the quality and quantity of our breeding stock. In the past three years, we have retained our best fillies in additional to making strategic purchases to elevate the quality our stock.

I feel that the ASHA must continue to encourage members to improve quality of the breed. This can be accomplished through show presence / sponsorship and breeder education.

I have used all of the services provided by the ASHA. As a result, I am aware and familiar with these services. Generally speaking, I find them reasonable and helpful. Specifically, I have attended a national board meeting and I have exhibited in both regional and national shows.

My contributions to the board will be enhanced by having first-hand experience with ASHA services. Combined with my 40+ years of business management and board of directors' experience, I am confident that I can bring ideas and procedures that may be of benefit to the ASHA Board.

I currently own 23 registered Shires. We have 12 mares, 3 stallions, 4 geldings and some "young-stock" and usually raise 5-6 foals a year, some are kept as replacement breeding stock and some are sold. My family has a 6-horse hitch of home-raised registered mares and geldings that we travel and show with as well as several halter horses. I have shown my Shires all over the United States and hold numerous Regional, State and National halter titles and hitch awards. I'm also a firm believer in taking my Shires out to "meet" the public and routinely take my horses to schools, nursing homes, hospitals and educational events to "promote" the Shire horse and its' many wonderful qualities.

I served on the ASHA board of directors (BOD) from 1999-2003 and was instrumental in developing and encouraging the promotion of the "Shire Sporthorse" and its subsequent registry. I've served on numerous committees for the ASHA and was one of the "writers" of the original "showmanship guidelines" and show rules. I've also served on the BOD for the American Dairy Goat Association, Colorado Draft Horse Association and Western Slope Driving Chapter. I am familiar with the operations of a Board of Directors and understand the duties that I will have to undertake if I am elected. I plan to continue to promote the Shire horse by breeding high quality horses and showing them to the best of my ability. I will also continue to take my horses "out" into the public arena and promote the wonderful, versatile Shire. - Maintain a separation of duties and segregation of positions between the board as an oversight group and the employees of the association.

I am able and willing to commit to perform the duties required of a Board member.

During my career, I developed an interest in animal traction as it applied to the historical development of the U.S., and is currently related to animals' widespread use in developing countries today. That ultimately led me to the Shire, based in part on the breed's fragile gene pool due to its relatively low population among draft breeds.

I've owned Shires since I bought my first pair as weanlings in 1998. Having not found a trained team, and due to my inexperience at the time, I decided to buy a young pair with which to learn together. Not being a complete novice, it worked great without injury, train wrecks or rodeos. Since then I bought two mares. I bred one by a.i. two years ago. It was a great experience, resulting in a fine filly, now a yearling.

Basically, I work alone which makes showing difficult, although I haven't slammed the door completely on that enterprise. I consider my Shire involvement as recreational/hobby-not business.

I use my horses in local parades and offer wagon rides at community events which always creates interest in my "Clydesdales" (as perceived by the public-including horse folks.) I'm training my horses under saddle as well. I hope to use one or more in local trail rides.

I've used ASHA to register and transfer horses and I monitor Shires4Sale.com. Of course, I'm interested in communication opportunities through the Member's Message Board, and view this as a very good communication tool that could be expanded.

I've participated as a member of the Nominating Committee and the Education Committee, and have attended two annual meetings in the last few years. I wrote a fairly comprehensive article several years ago on West Nile Virus that was used in the Newsletter.

My thirty-year career as a university extension educator involved work in 4-H, agriculture, natural resources and community development. I helped or led in the establishment of boards and non-profits and served on a number of boards and commissions, which I view as strengths I might bring to ASHA.

I support the over-all purposes of ASHA and would sign the Director's Pledge without reservation. Three issues of importance to ASHA are:

- Strengthening its financial position: Current financial challenges have been made worse by a lengthy legal issue that is now behind the Association. I'm optimistic that the Association will regain financial stability.
- Expanding membership base: A possibility might be to establish a category of membership called Associate Member that would be for members simply

interested in preservation and enhancement of the breed.

• Continued adoption of new technology such as DNA testing to enhance pedigree accuracy and animal identification at competitive events. I do admit to having reservations relative to the National Animal Identification System (NAIS) and how it might ultimately apply to equines and ASHA members.

I generally support the notion of developing a system that would enhance ASHA's ability to register superior breeding stock.

A matter of personal importance is the condition of "scratches" which my geldings exhibit. While controlling the condition fairly well, I definitely support anything that might reduce its incidence in the population, which I believe has a genetic component.

I have a low tolerance for dishonest and unethical behavior, while recognizing that there can be honest differences of opinion on many issues. I'm a pretty transparent person and have no personal agenda. It is my impression that the currently seated Board is working in a cooperative and harmonious manner toward a common goal. If elected to the Board, I would make every attempt to maintain a collegial atmosphere while remaining independent in my thinking and action.

I am committed to attend all required meetings. I hope to continue the work I have started regarding the stallion inspection and printed studbook.

I do not own shires and this may be looked at in a negative way by some people, but I am 100% dedicated to the Shires in my care. I also have 100 % commitment to the Shire as a breed, and as we move forward into another year it is imperative that all the ups and downs of the past 4 years get put away. If we don't unite now; the loss of this majestic animal will become a very real situation. I believe that as breeders we need to be responsible in the way we breed. The modern Shire is a far cry from its predecessor; with horses that seem to get taller and whiter. This, in conjunction with the smaller number of horses being bred, will spell disaster when the gene pool is so small that the true Shire will be lost forever.

In the 3 years that I have shown Shire horses I have appeared on the front page of at least five national horse driving magazines. I think this speaks volumes to the Shire's ability to be used outside of the hitch class or pulling a farm implement.

My future goals will be to get a working stallion inspection in place that will be acceptable to most of our membership so that we can finally have a reciprocal agreement with the SHS; which I believe will encourage a larger market for our breeders that rely on selling horses for their livelihood. I would like to finally get an informational worldwide stud book online so that breeders can research horses to make the best decision in their breeding. Also, I would like to put on driving clinics for people who would like to do more pleasure driving in the English style.

A goal that I would like to see ASHA achieve is having a good, solid, reasonable amount of revenue coming in each year as well as exploring new ways that we can attract new members while keeping our established members.

I have worked in the horse industry (in all disciplines) for about 25 years and bring a wealth of experience and fresh ideas to the table. I rode in the English army and competed in dressage eventing and show jumping. Show jumping was part of many ceremonial parades in London. I have driven horses for two royal families and trained horses using natural methods for many years. Currently I show draft horses, and light horses in pleasure driving. I believe that these two very different worlds can co-exist and benefit from each other's methods.

I utilize all of the various services currently offered by the association. I think that in the future, registrations and transferring can be more efficient and "carbon friendly" if the various forms could be filled out on line. My participation in the ASHA in the last couple of years includes organizing this year's visit to the carriage museum in Florida, working on the stallion inspection exploration committee, and putting together the printed studbook. My latest efforts have been working with the ALBC to move the Shire to critical on the rare breed list.

The most important issue facing the ASHA is the breed itself. We need to work hard at increasing the amount of horses being bred and registered. If we can encourage a broader use of the Shire we would increase the need for more Shires to be bred. This is, however, a double-edge sword. We should not lose sight of what the Shire horse should look like while encouraging good breeding

The second issue that needs to be looked at comes hand-in-hand with the first in that we need to have a stallion inspection to insure that breeding stallions conform to whatever guidelines that are set by the ASHA. However, this inspection must be set up in a way that personal or political motives cannot influence an outcome.

The third most important issue facing the ASHA at this time is to increase membership and try to bring back into the association valued members along with their knowledge. We also need to encourage new members and create an atmosphere of education and mentorship so they can learn "how" to be successful in the show ring as well as in breeding.

Proposed By Laws Changes for Member Vote

1. Addition of a Youth Membership Category to the By Laws

The following was proposed by Melissa Restifo to expand ASHA's promotion of and interest in youth involvement with Shires and the Association.

The current Youth Achievement Program (YAP) has recruited youth who are already involved with Shires, but has not been successful getting new youth involved with the Association or Shires. Addition of a youth membership category in ASHA may help increase youth interest in Shires and the Association.

The proposed youth membership category would have no lower age limit and an upper limit of 18 years of age, which is the current cut off for the YAP. Annual dues would be \$15.00. Youth members would receive a welcome packet, membership card, a copy of the youth guidelines and access to the YAP, if desired. Depending on level of interest, other benefits could include reduced fees for some services and association activities, a youth members message board on the website, year end high point awards for Shire related activities and possibly a youth newsletter or page in the existing member bulletin. This membership category will not have voting privileges. However, individuals under 18 may still choose to join as regular members for full privileges and responsibilities in ASHA.

In order to set up a youth membership, the by laws must be amended to include this category. The proposed modifications to include a youth membership category in the existing by laws are as follows: (added text is in *italics*. Deleted text is struck through with a line.)

ARTICLE III. MEMBERS

Section 1. <u>Classes of Members.</u> The Association shall have two three classes of members:

- (a) Regular: eligible individuals; and
- (b) Corporate: eligible firms, including corporations, partnerships, trusts, limited liability companies, and other legal entities; *and*
- (c) Youth: eligible individuals.

Section 2. <u>Eligibility For *Regular and Corporate* Membership</u>. Membership in the Association shall be open to all persons, firms and/or corporations who have been, or are at the present, or who likely will be, interested in the raising and improvement of horses, particularly Shire horses. Only natural persons shall be eligible for lifetime membership. Representatives of corporations, businesses or other legal entities shall not be eligible for lifetime memberships.

Section 3. <u>Eligibility for Youth Membership</u>. Eligibility for youth membership requires that the individual be under eighteen years of age on the postmark date of the application for membership. No life memberships are available for youth members in this category.

Section 4. Application for Membership.

Any person, firm and/or corporation desiring to become a member of the Association shall complete an application for membership and submit it, together with the current lifetime, or annual, or youth membership dues, to the Secretary of the Association.

Section 5. Voting Rights.

Each Regular and Corporate member shall be entitled to one vote on each matter submitted to a vote of the members. Each corporate member shall designate, in writing, a member, shareholder, or other agent who shall be authorized to exercise such member's vote. Members shall not be entitled to vote, serve as directors, or hold an office in the Association during the first six months of membership. A member who is not a lifetime member shall be considered a member continuously from the date his or her membership first began unless terminated in accordance with Section 6 of this Article. *Individuals holding Youth Membership are not eligible to vote on Association business.*

Renumber existing sections #'s 5 through 9 to #'s 6 through 10.

2. By Laws change to prohibit board members from serving concurrently as association secretary. Submitted from member concerns.

The current by laws do not prohibit a member from serving as both a board member and secretary. There is historical precedent in the association of a member holding both positions, but at those times the secretary position was not paid or received only a nominal stipend. There is some member concern that since the secretary position is now salaried, the possibility of conflict of interest is present if one person is both a member of the board and the secretary. They feel this situation should be avoided.

Background research with on-line help websites for nonprofits indicates this situation can be acceptable, depending on the size and resources of the organization and internal checks and balances. From a policy standpoint, one person holding both positions results in one less person to help with the work of running the association (9 board members, <u>including</u> the secretary or 9 board members <u>plus</u> a secretary).

The proposed modifications to the existing by laws to prohibit board members from serving concurrently as secretary are as follows: (added text is in *italics*. Deleted text is struck through with a line.)

ARTICLE V. BOARD OF DIRECTORS

Section 1. General Powers. NO CHANGES

Section 2. Number, Tenure and Qualifications. The number of directors shall be nine. The directors shall hold office until the beginning of the annual meeting of the board of directors following the election at which their successors shall have been elected and qualified. Directors need not be residents of the State of Washington, but must be Regular members of the Association. Directors shall be elected for terms of four years, and may not serve more than two consecutive terms. The election of directors shall be staggered so that four or five directors shall be elected during November of each even-numbered year, as appropriate, to take office at the beginning of the annual meeting of the board of directors in the following odd-numbered year. A member who has served two consecutive terms as a director shall be ineligible for re-election to the board of directors until the next even-numbered year following the end of the member's second term as director. Starting in 2011, a director may not hold the position of secretary of the Association during their tenure as a director.

ARTICLE VI OFFICERS

Section 1. Officers. NO CHANGES

Section 2. Election, Eligibility and Term of Office. The

president, vice president and treasurer shall be elected biennially by the board of directors at the regular annual meeting of the board of directors in odd-numbered years. The secretary shall be appointed annually by the board of directors at the regular annual meeting of the board of directors. Additional offices may be created and filled or terminated at any meeting of the board of directors. The officers shall be elected from among the board of directors, except that the secretary does *not have to be a member and*, *starting in 2011, shall not be a director*. Assistant secretaries and assistant treasurers shall not be required to be directors or members of the Association. Officers shall hold office until their successors shall have been duly elected and shall have qualified, unless their offices are sooner terminated by the board of directors.

Sections 3 through 10: NO CHANGES

Section 11: <u>Compensation</u>. Directors as such shall not receive any stated salaries for their services, but by resolution of the board of directors a fixed sum and expenses of attendance, if any, may be allowed for attendance at each regular or special meeting of the board, or for conducting the business of the Association duly delegated to a director by the board; but nothing herein contained shall be construed to preclude any director from serving the association in any other capacity, *except secretary*, and receiving compensation therefor.

Sections 12 through 14: NO CHANGES

According to the Association by laws, in order to set up electronic delivery of information from the association to the members, members must request this method of communication.

If you would prefer to receive your quarterly bulletin elec-tronically, send an E-mail to Karla Stoner at bloomforge@ peoplepc.com requesting this option. Once we have names of those who would prefer the electronic method, an address list will be set up and mailings will be initiated. The main advantage of this method will be quicker delivery of the bulletin. Members requesting electronic delivery will have to maintain current E-mail addresses with the Association to insure continued delivery.

Members preferring to receive their bulletins through the regular mail will continue to do so.
