# Registration Rules Changes for frozen semen and embryos

This summer, the board approved revisions to the Registration Rules for foals resulting from frozen semen or embryos. The full text of these rule changes will be posted on document section of the website in revised Registration Rules.

To Summarize:

- ◆ The office will set up and maintain a Genetic Material Database to record the ownership of the original collection and retention of frozen semen or embryos.
  - The recorded owner or leasee of the animal at the time of collection must notify the office in writing that they have retained frozen semen or embryos. Forms for this notification will be available from the office or on line. In the case of leased animals, the lease agreement must be on file in the office and must allow the leasee to collect and retain frozen semen or embryos after the lease has expired.
  - Existing stores of frozen semen and embryos will be grandfathered into the new system with appropriate paperwork. (Details to follow.)
  - Foals resulting from frozen semen or embryos not on record in the database will not be recognized for registration purposes, unless the material is from another recognized Shire registry and the proper paperwork from that registry is included with the registration application.
  - If the donor animals are sold, retention of frozen semen or embryos by the previous owner(s) and/or leasee(s) must be recorded in the transfer document.
  
- ◆ In the case of subsequent sales of frozen semen or embryos, properly completed and signed Genetic Material Certificates must be transferred at the time of the sale in order for the new owners to be able to register foals resulting from this material.
  - Blank certificates will be provided free of charge, but owners are responsible for providing properly completed and signed certificates to the new owners with each sale of material.
  - These certificates will only be submitted to the office with a registration application.
  
- ◆ Registration of a foal resulting from frozen semen or embryo will require a supplemental fee to cover the costs of maintaining the Genetic Material Database. (Amount TBD at the December board teleconference.)
  
- ◆ These rules do not prevent recorded owners from selling frozen material without a certificate, but registration of any foals resulting from that frozen semen would require the recorded stallion owner's signature on the application. Frozen embryos sold without certificates, would require the dam's recorded owner to sign the registration application. However, this situation would incur a transfer fee in addition to the registration fee in order for the buyer of the embryo to be the recorded owner of the foal.

The Rules Committee is working on the form for recording the original collection and freezing of the genetic material and the certificates for subsequent sales of frozen semen or embryos. An announcement will be made when the system is ready to start accepting records.

### PROBLEM RESOLUTION GUIDELINES

Do you have a problem with the Association? If so, here are the guidelines to be followed for resolving the problem.

1. Ask yourself if it is an Association problem. If so, talk directly to the party with whom you have a problem e.g., committee member, secretary, board member, President, etc.
2. If you do not get satisfaction, put your complaint in writing to the party concerned. (Verify delivery.) The party receiving the complaint should respond to you in writing within 14 days of receipt.
3. If you are not satisfied with this response, submit a written complaint to a board member of your choosing in a timely manner. (Verify delivery.) The board member shall notify the President (or Vice President if the complaint involves the President) that he/she is working on a problem. The board member shall interview all parties concerned in an attempt to mediate the dispute and then give each party involved a written recommendation in a timely manner.
4. If you are not satisfied after step 3, submit a written complaint to be addressed by the full Board. The Board decision will be final and so recorded.

### Would You Like to Receive Your Bulletin by E-Mail ?

Due to continuing problems with USPS bulk mail delivery, the board voted at the teleconference on July 12th to begin routinely sending the quarterly members' bulletin by first class mail and to look into E-mail delivery of the bulletin (and possibly additional information in the future) for those who would prefer the electronic method. According to the Association by laws, in order to set up electronic delivery of information from the association to the members, members must request this method of communication.

If you would prefer to receive your quarterly bulletin electronically, send an E-mail to [Karla Stoner at bloomforge@peoplepc.com](mailto:Karla.Stoner@peoplepc.com) requesting this option. Once we have names of those who would prefer the electronic method, an address list will be set up and mailings will be initiated. The main advantage of this method will be quicker delivery of the bulletin.
