**REQUEST FOR PROPOSALS
FOR NEWSLETTER DESIGN AND PRODUCTION SERVICES
AMERICAN SHIRE HORSE ASSOCIATION
DECEMBER 30, 2009**

INTRODUCTION

The American Shire Horse Association (ASHA) is seeking a qualified and experienced vendor to provide quarterly newsletter production services. Proposals must be in the form required by this Request for Proposal (RFP). Selection of a vendor will be made by the ASHA Board of Directors (BOD) after the closing date for proposal submission.

The quarterly newsletter is ASHA's communication tool with its membership and should be well organized, aesthetically pleasing, contain all information as designated by ASHA and be error free. Meeting publication deadlines is critical.

The vendor should have an experienced background in desktop publishing, graphic design or related fields that would enable to vendor to produce an excellent product for ASHA.

The vendor will be responsible for selecting a cost-effective printing and mailing house. ASHA has limited resources and requires an economical vendor who can creatively develop cost effective strategies for newsletter design and publication.

ABOUT ASHA

The American Shire Horse Association is a small, nonprofit breed registry for the Shire horse. ASHA was founded in 1885 and maintains a national studbook in which purebred Shire horses are registered and bloodlines recorded. There are approximately 330 ASHA members. The majority are in the United States, with a few in Canada and overseas. The ASHA bulletin is used to report ASHA business activities, registrations, transfers of ownership of horses, and other business of interest to the membership. All members will receive the ASHA bulletin.

MINIMUM MANDATORY REQUIREMENTS

Proposers are required to

- Have at least two (2) years' experience in desktop publishing, graphic design, or a related field.
- Submit two (2) recent samples of a graphic design newsletter, pamphlet, brochure or other written promotional device.

CONTRACT TERM

The contract shall be in one year increments. Contracts can only be renewed by the ASHA board president. The contract can be terminated by either party with 90 days advance notice.

CONTRACT AWARDED ACCORDING TO ASHA'S INTENDED PURPOSE

The contract shall be awarded through a competitive process to the responsible and responsive Proposer(s) whose cost, experience, and approach to the project and organizational resources are deemed most suitable to ASHA's needs.

ASHA RESPONSIBILITY

ASHA is not responsible for representations made by any of its officers or employees prior to the execution of the contract unless such understanding or representation is included in the contract.

TRUTH AND ACCURACY OF REPRESENTATIONS

False, misleading, incomplete or deceptively unresponsive statements in connection with a proposal shall be sufficient cause for rejection of the proposal.

INADEQUATE, INCOMPLETE, NONRESPONSIVE OR LATE PROPOSALS

It is the proposer's responsibility to ensure proposals are a correct and timely proposal is received by ASHA. Proposals determined by ASHA to be incomplete, inadequate or nonresponsive will be rejected.

PROPOSAL DUE DATE

THE DEADLINE FOR RECEIPT OF PROPOSALS IS 5:00 pm CST ON JANUARY 22, 2010. Proposals must be received by the deadline date and time. Postmarks will be disregarded. Proposals are mailed at the proposer's risk. If mailed, one original and five copies must be delivered to:

It is the sole responsibility of the proposer to ensure that its proposal is received prior to the submission deadline. Submitting proposers shall bear all risks associated with delays in delivery by any person or entity, including the U.S. mail, private carriers and electronic mail. Any proposals received after the scheduled closing date and time will not be considered, and will be discarded.

REQUIRED FORMAT AND CONTENT OF PROPOSAL

Proposals shall be developed according to the guidelines set forth in this RFP. The proposals must be specific and complete in every detail. Failure of a proposal to conform to these requirements may result in rejection.

ADDITIONAL INFORMATION

Proposers may attach to their proposals any information that would aid ASHA in making its decision. Additional information may be requested by ASHA to evaluate the proposer's ability to perform the work.

SELECTION PROCESS

ASHA reserves the sole right to judge the contents of the proposals submitted pursuant to this RFP and to review, evaluate and select the successful proposal.

ITEMS CONSIDERED FOR SELECTION

Items considered for selection of the successful proposal include, but are not limited to, approach to contract requirements; proposer's experience and organizational resources; proposal price; and references.

STATEMENT OF WORK

The Contractor will be responsible for the timely and complete fulfillment of the following requirements:

1. Newsletter concept, information organization, writing, editing, design, and layout.
2. Conversion and formatting services so newsletter can be published online.
3. Research, develop and provide concepts for printing to ASHA for approval.
4. Meet all quarterly publishing deadlines.
5. Select, retain and coordinate publishing and distribution of newsletter through an ASHA approved publishing and mailing vendor.
6. Work cooperatively with ASHA designee to develop content.
7. Develop and organize content of a newsletter in an aesthetically pleasing format.
8. Submit proofs for review to ASHA designee prior to publication.
9. Maintain communications with ASHA representative to ensure post office account is maintained with the necessary financial balance to mail newsletters.
10. Maintain correct and current mailing list to ensure all members receive their newsletter.
11. Format of newsletter shall be:
 - a. 16 – 18 pages
 - b. 8 ½ x 11" format, folded, stapled, labeled with addresses
 - c. Black and white
12. Content of newsletter shall include:
 - a. Registrations and transfers of horses
 - b. President's message
 - c. List of current fees
 - d. Quarterly financial documents
 - e. Horse show results (seasonal)
 - f. Meeting announcements
 - g. Election information
 - h. Other news of importance to the ASHA membership as deemed necessary by ASHA.

Minutes of ASHA Board of Directors Teleconference Meeting Saturday, 12/12 & 26/2009

Motions summary:

12/12/2009 Motions:

- Janet moved and Gene seconded that the minutes from the May 30, 2009 teleconference be approved as written. Motion passed.
- Gene moved and Janet seconded that the secretary's report submitted by Pam Correll be approved as submitted. Motion passed.
- Gene moved and Danelle seconded to recess the meeting until 12/26/2009 at 10:00AM EST. Motion passed. Meeting recessed at ~11:00 AM, EST.

12/26/2009 Motions:

- Gene moved and Janet seconded that Dan ask Ken Knuth if he would be willing to fill the board position vacated by Marcia Mayeda's recent resignation. Motion passed.
- Gene moved and Karla seconded that the board appoint Janet Long as the interim Treasurer until the Annual Meeting. Motion passed. Marcia will assist in the transition.
- Gene moved and Danelle seconded that there be no additional registration fee for maintenance of the frozen genetic material ownership database [*in cases of registration of foals resulting from frozen semen or embryos*]. Motion passed.
- Janet moved and Danelle seconded that the 2010 National Show be held at the Oklahoma State Fair, Oklahoma City, Oklahoma. [*Tentative dates September 16 – 18, 2010*]. Motion passed.
- Gene moved and Danelle seconded to adjourn the meeting. Meeting adjourned at 11:19 AM, EST.

1. The meeting was called to order on 12/12/2009 by President Dan Hubbell at 10:02AM, EST. On 12/26/2009 the meeting was reconvened by Dan Hubbell at 10:03 AM, EST.
2. Roll Call was taken by President, Dan Hubbell at both sessions of the meeting:
 - 12/12/2009 Board members present: Dan Hubbell, Janet Long, Danelle Kinney, Gene McCaffrey and Kim Murchison. Absent: Pam Correll, Karla Stoner, Marcia Mayeda and Paul Tyrrell.
 - 12/26/2009 - Roll call was taken by Dan Hubbell: board members present: Dan Hubbell, Janet Long, Danelle Kinney, Gene McCaffrey, Karla Stoner, with Paul Tyrrell joining the call at 10:13AM, EST. Absent: Pam Correll and Kim Murchison.
3. Additions or Deletions to the agenda: Nothing added during the 12/12/2009 session. On 12/26/2009 Under New Business – Dan added the resignation of Marcia Mayeda and Marcia's draft of a request for proposal (RFP) to produce the members' bulletin. The agenda was left open for other additions during the meeting.
4. Reading and approval of minutes not yet approved. 12/12/2009 - Janet moved and Gene seconded that the minutes from the May 30, 2009 teleconference be approved as written. Motion passed.
5. Secretary's report – (Attachment #1). 12/12/2009 - Gene moved and Janet seconded that the secretary's report submitted by Pam Correll be approve as submitted. Motion passed. Kim asked about the status of the year-end transaction reports from QuickBooks for those members needing them for tax purposes. Dan asked Kim to check with Pam on these reports.
6. Treasurer's report – Tabled at both sessions of this meeting due to the absence of the secretary and treasurer.
7. Resignation of board member. Marcia Mayeda submitted her resignation to Dan, effective on 12/15/2009. The board discussed options to fill the position. Dan suggested asking Kent Knuth. Gene moved and Janet seconded that Dan ask Ken Knuth if he would be willing to fill the board position vacated by Marcia Mayeda's recent resignation. Motion passed. After further discussion on the Treasurer's position, Gene moved and Karla seconded that the board appoint Janet Long as the interim Treasurer until the Annual Meeting. Motion passed. Marcia will assist in the transition.
7. Committee reports – all reports given on 12/26 unless otherwise noted.
 - a. Rules Committee – Gene and Karla - Frozen Genetic Material - The question of a supplemental registration fee to cover expenses of maintaining the database for tracking ownership of frozen genetic material was discussed. Gene moved and Danelle seconded that there be no additional registration fee for maintenance of the frozen genetic material ownership database [*in cases of registration of foals resulting from frozen semen or embryos*]. Motion passed. The following points were tabled until the annual meeting: Possible modification of rules for changing registered names of horses and rules for registering prefixes.
 - b. Breed Show Committee – Vicky came on line to ask the board to approve the committee's recommendation for the location of the 2010 National show at the Oklahoma State Fair. Janet moved and Danelle seconded that the 2010 National Show be held at the Oklahoma State Fair, Oklahoma City, Oklahoma. [*Tentative dates September 16 – 18, 2010*]. Motion passed. Vicky also reported that the committee will have a list of recommended locations for future national shows at the annual meeting.

- c. Trade shows and merchandise – Karla reported that proceeds from merchandise sales were down this year, partly due to the economy and partly due to clearance sales of older merchandise. Most of the older t-shirts have been cleared and the inventory is being streamlined. Contacts for someone to take over this committee have not been successful this year. Inventory value will be determined as of the end of the year and a report will be made to the board with recommendations for 2010.
 - d. Fundraising - Foundations status: 12/12/2009 Dan reported that The American Shire Horse Education Foundation now has its tax ID number and can accept tax deductible donations. Heinz Naef will give a full report at the annual meeting in January.
 - e. Membership Services – Karla recommended increasing the number of times new member packets are sent out from once a month to twice a month to prevent new members who join at the beginning of a month from having such a long wait to receive their membership information. Nanette Osterhoudt has agreed to give this a try. The board felt this was a good idea. Karla will contact Pam and Nan to get this started.
 - f. Magazine – 12/12/2009 - Concerns about cost, decreasing advertising revenue and problems with publication deadlines were discussed along with possible options. While the general consensus was that the magazine would not continue in its current form, further discussion and a final decision were tabled until additional information from Village Press (VP) could be obtained regarding the contract status and more board members were present for a vote. 12/26/2009 – information from VP was still not available and several board members were unable to make this meeting. The matter will be handled on line and at the Annual Meeting.
 - g. Members' Bulletin – Dan will contact Kathy and Pam to find out the status of the last 2009 issue of the bulletin. The board wants the issue out by the 5th of January at the latest. Pam has submitted a proposal for taking over the bulletin and Leandra Reuble has also expressed interest in this project. Dan recommended opening this project to the membership, using Marcia's draft of the Request for Proposal (RFP) to produce the bulletin in 2010. Board members felt that this was the best approach. After some modification, the draft RFP Marcia submitted will be posted on the website and in the next bulletin. It may also be sent out to other potential vendors. There will be a return deadline date of January 22, 2010 so the information will be available to the board prior to the annual meeting where a direction will be determined.
 - h. Youth – Danelle reported that there are only two active youth members. The new youth membership information has been added to the ASHA membership application and posted on the website and in the bulletin. A very nice article on one of the youth members was published in the summer issue of the magazine. Danelle hopes to see some increased interest from that article.
 - i. Stallion inspection – Paul will be sending out status information in PDF format to committee members in the next few weeks. Some committee members were unable to open the earlier communication.
 - j. World Wide Studbook – Paul & Janet – Janet is in the process of setting up an interface to assist Paul in entering SHS horses.
8. Old Business
- a. Annual meeting update – 12/12/2009 - Kim reported that the information is up on the website home page. People need to make reservations at the hotel and reservations for education day with Kim (thshire@sopris.net). A bulletin announcement was been made in early December and a second bulletin announcement is planned for early January 2010. Education day will take place at the hotel where the meeting will be held. If 10 rooms are booked at the hotel, the meeting room will be provided free of charge. Hopefully, the education day fees will cover speaker costs and printing of the educational booklets. If possible, extra copies of the booklets will be for sale to the membership after the meeting.
