Shire Alternative Competition Points Program (SAC)

The Shire Alternative Competition Points Program (SAC) knows that the Shire and the Shire Sport Horse are talented and versatile individuals that perform in many activities and events outside of the ASHA sanctioned National and Regional Shows. The goal of the SAC program is to recognize those horses and owners for their accomplishments in the competitive events that they enjoy.

SAC accepts nominations for many equine organizations, fairs, local draft horse associations and competitive trail rides. Many shire owners live and participate in local events and activities that fall outside the category of an “ASHA-approved National and regional show.” SAC also recognizes each year State Sanctioned Fairs, Corporate Shows and Stock Shows, like Denver Stock Show or Calgary Stampede. A working list of these preapproved shows is in this document. Follow the guidelines as posted to enter these shows and count your points. If you have a show that fits in this category, please submit it for nomination.

SAC will record performance and halter points from many local nominated shows. These points will add up and horses will work to many award levels and receive SOM (Shire of Merit) awards as they reach these milestones.

Even though the ASHA is not officially associated with many these events, the association does want to recognize the efforts of shire owners using their Shire and Shire Sport Horses. As a result, Shire horse owner’s accomplishments will be recorded on all registered Shire horses. These points are then listed on their official performance record with the ASHA.

The SAC program is open to most types of competitions. Organizations must keep official records of the show for one year. Anytime through that year the SAC Secretary may request copies of those results for verification of points and entries.

In order for a show to be eligible for nomination the event must be sponsored by an association, organization or affiliate that has:

- 1) An established record- keeping system
- 2) Established governing body (Board of Directors),
- 3) A representative (usually the show secretary) that will sign the forms.

**PROCEDURAL GUIDELINES FOR
NOMINATIONS AND ELECTIONS TO ASHA BOARD
OF DIRECTORS**

- I. The Nominating Committee shall be in place by the last day of March of the election year.
- A. The Committee shall consist of two Board members and three members at large, all in good standing and eligible to vote as defined by the By-Laws.
- B. Members of the Committee are NOT eligible to run as candidates.
- II. In the spring newsletter shall be printed:
- A. The nominating process.
- B. The name of the chair and committee members with their postal address, e-mail address and phone number(s).
- III. The final ballot shall be of sufficient number of candidates to fill the Board positions to be elected plus at least one.
- A. Only members in good standing and eligible to serve as defined by the By-Laws are eligible to run.
- B. The Nominating Committee may solicit volunteers to become candidates for the Board. **Members wishing to run must contact a committee member IN WRITING by USPS or by e-mail by July 20.**
- C. By August 1, all candidates will receive a short form requesting the following information:
1. Name, address, phone number, and e-mail address.
 2. A statement of ability and commitment to attend membership and board meetings and do committee work should they be elected.
 3. A brief statement of strengths and contributions candidates can bring to the board (200 words max).
 4. Brief responses to a set of questions posed by the committee and regular members.
- D. The forms shall be completed and returned to the Chair postmarked no later than August 20. Forms postmarked after August 20 will not be considered.
1. The Chair shall forward copies of the completed forms to all committee members by August 30.
 2. All completed forms will be sent to the Secretary with the final slate.
- E. The Committee will confirm eligibility, review the written responses of all candidates and determine the final slate of candidates. The Chair will then notify all committee members, board members, and the ASHA Secretary of the final slate by September 10.
- F. The final slate shall be printed in the fall newsletter with the candidates' names, postal and email addresses, phone number(s) and personal response forms.
- G. There shall be no maximum number of candidates.
- IV. The ballot shall be sent to all eligible voting members as defined by the By-Laws by first class mail no later than October 31.
- A. The candidates will be listed alphabetically, by last name, on the ballot.
- B. Each ballot shall include an envelope addressed to the ASHA Secretary in care of the Notary Public appointed for ballot counting.
- V. The election deadline date will be stated in the mailed notice.
- A. Any ballots postmarked after the deadline date will not be counted.

- B. The appointed Notary Public shall tabulate all valid ballots one week after the deadline stated in the notice.
- C. Upon finishing and verifying the outcome, the Notary shall immediately notify the Nominating Committee Chair and the President of the results.
1. The Chair shall notify the Secretary, the Committee, the candidates, and the board members of the results as soon as possible.
 2. The results must not be released to anyone else until December 21 or until all of the above have been notified, which ever comes first.
 3. In the case of a tie, the Chair will contact the candidates involved. If one wishes to withdraw, the other shall be the new board member. If both wish to continue, their names shall be placed in a container and the Notary Public shall draw the name of the winner.
- D. The new board members shall be announced in the winter newsletter.

The Nominating Committee is looking for candidates to run for the five positions that will be vacated December 31, 2010. A Board member is elected to a four-year term and accepts the responsibility of participating in key decisions that affect the way the ASHA functions. They are expected to attend one meeting a year at their own expense, regardless of where in the US it is held, and in addition should be willing to take part in quarterly board teleconferences. Board members also serve on committees and volunteer for other duties as needed on behalf of ASHA. Being a board member can be a rewarding and pleasurable experience. Anyone who desires to run is requested to notify in writing or by email, one of the committee members listed below by July 20, 2010.
