On a Shire note it saddens me to think of those we have lost- their memories will forever, live bright in those they have touched and who think of them and their smiles often.


Show season has come and gone.... Thank you to all who showed and promoted your horses in and out of the show ring this year. Without you and your support our breed would not be seen as often by the public.

News from the Office -- Secretaries Message:

It's sort of like riding a bicycle – takes a bit to remember the feel of things, but once you get rolling.... For those who are wondering, I served as ASHA's secretary from 1996 to 2002 and as Sheila's assistant for a year after that, so getting back on the bike to assist during this transition wasn't that hard.

Some things have changed and some have stayed the same. I love being able to use email for many aspects of the job, such as sending out DNA kits rather than printing and mailing hard copies. VGL's new website also makes ordering kits easier. Fall brings the usual flood of requests from school kids doing reports. There are the calls and emails from people who have rescued a horse (bless them!) and are "just sure she's a Shire, so how do I get her transferred into my name" - hate to disappoint them with my reply.

For the most part, things have gone smoothly. The exception, for some of you, may have been in calling the office. We set up a new Vonage system so we could use a toll-free number and wouldn't have to change the office number, but in recent weeks I've noticed that sometimes when there's a Vonage email that says "listen to your voicemail for the rest of the message," the voicemail says "You have no new messages." Not good. If you leave a voicemail, please leave your phone number at the *beginning* of the message to be sure it is captured in the system. You can always call me anytime at 970-876-5979 (has an answering machine) or 970-876-5980 (has the Vonage system). Please remember that we're in the mountain time zone, 2 hours earlier than the east coast. (I.e. 9am ET is 7am MT.)

There is a group of good candidates for the secretary's position – the board will begin to narrow the field by the time you receive this newsletter. I am excited that the association is in a position to move forward when (as I expect) the demand for Shires picks up again. There is always a demand for good horses, and we are lucky that we are working with a breed whose personality makes them special.

Please let me know if I can do anything to help you over the next several months. Remember that the registration amnesty period ends at the end of the year, so if you have horses you haven't registered, now is the time!

I've Just Bought a Weanling, Now What?

Training your Weanling By: Kim Murchison, Owner Tally Ho Shires

We usually wean our foals between 4 to 6 months old, depending on the status of the mare. Some mares will milk and feed a foal and never lose any weight, while other mares really begin to "pull-down" or drop weight after about 4 months of suckling a foal. Many people that purchase foals receive them shortly after weaning, so the following guide is written to aid in the training of your weanling foal.

When it is time to wean the foals, we like to wean them in pairs. We bring each foal in, and place each of them in a box stall in the barn. I believe that it's important for each foal to be separated in their own stall, this allows the foal to focus solely on its human caregivers and bond with you. Make sure that the stall is free from any sharp objects and that the foal can't get hung up on anything if they should try to jump, which many do. Make sure and take the halter off of the foal while it is in the stall.

For the first day or two, the foal remains in the stall with fresh water and feed in front of them at all times. I don't handle the foal at all for the first few days. Many times during those first few days, the foal with run around in the stall, whinny and try to jump up the walls (this doesn't always happen, but don't panic if it does). Talk quietly to the foal from outside the stall (we like to leave the radio on in the barn at this point to create human noise).

Usually after about 3-4 days, the foal is calm and ready to interact with you. I open the stall door and talk quietly to the foal. If the foal comes to you, they are ready to inter-act with you. If they don't, I shut the door and try again later. If you wait for the foal to decide to interact with you, it's a much more positive experience than if you force the issue.

Once the foal is ready to interact with me, I begin by hand-walking (or putting the foal on the hot-walker) for about 15-20 minutes in the morning and evening. I also begin putting the foal in cross-ties and grooming them for about 10-15 minutes each day. My "foal" cross-ties have inner tubes between the rope and the wall so that if the foal pulls back, there is "give" and the foal doesn't get hurt. I make sure to pick up all of the feet and rub the foal all over during each of my grooming sessions.

After about a week in the barn, I begin tying my foals to the back of the practice wagon when I take the hitch horses out to work them. My husband put a tie-bar on the back of the wagon so that I can tie a foal on each corner. I have a friend that put a tie-bar on the back of her pioneer fore-cart for the same reason. After being next to their working dams as foals, going along with the wagon at this point in time is pretty natural for them. If you are doing this for the first time, make sure and have someone along behind the foals to encourage them to walk-on when the wagon starts off. The foals are then exposed to flapping flags, barking dogs, vehicles and equipment as they go down the road behind the wagon, and I'm able to work the hitch horses and foals together.

After going out on the wagon, the foals are treated like the hitch horses. Upon re-turning to the barn, each foal is hosed down, slicked off, feathers oiled and body groomed. I also throw a cooling sheet on them while they are standing in cross-ties to get them used to wearing blankets. Each foal goes out on the wagon for short jaunts every other day. This is a great way to "legup" your foals if you are planning to show them. It also gets them into the routine of a show barn.

About two to three weeks after the weaning process is started, we begin turning our foals out into their paddocks (this is why it's nice to wean them in pairs) at night and bringing them into the barn during the day, just like the hitch horses. They learn to lead in and out of the barn like ladies and gentlemen. I keep each foal in a box stall during the day, and good quality grass hay in front of them at all times.





German Equine Theatrical Group is Requesting Shire Participation in their 2012 - 2013 U.S.A. Tour

Dear ASHA Member,

A representative of Massine Productions Gmbh in Germany, producers of the equine theatrical show Appassianta, has contacted ASHA to help identify people with one or two Shires who would be interested in traveling with the show for their U.S.A tour from April 2012 to September 2013. This show is similar to Equine Affaire Fantasia performances and received the 2010 PGR Live Entertainment Award for "Show of the year". Their website is <u>www.appassianta.de</u>

They are looking for one or two Shires to be ridden in a short act – probably together with a small pony to contrast the different sizes. The higher the level of under saddle schooling on the horse, the better, but performing at the three gaits in a nice, simple dressage demonstration it would be acceptable. Horses must be stallions or geldings (no mares) and should be tall, good looking and well groomed.

The tour would start with the rehearsals around end of February 2012 in Ohio. The show will Premiere in Louisville in Kentucky at the end of April 2012 and then continue around the country for about 66 show weekends /cities until the end of September 2013.

The company would prefer one person with one or two horses for the tour. However, considering the amount of time involved and the travel distances, they would consider using one person and horses for the first half of the tour and a second person and horses for the remainder. <u>2012 Education Day and Annual Meeting</u> <u>– One of the Best Yet for ASHA</u>







UNDERSTANDING HORSE INSURANCE RESPONSIBILITIES

Whether a horse is purchased for personal or business reasons, ownership represents a significant investment of time, money and resources. While no one likes to think about the potential for tragedy, horses seem to be prone to illness, accidents and injury. Should some peril befall your horse, nothing may ease the emotional burden, but wise planning can help reduce the economic impacts.

Many reputable insurance companies offer policies to help protect owners from financial loss should a horse become ill, incapacitated or die. Because individual policies vary widely from company to company and circumstance to circumstance, it is beyond the scope of this brochure to explain how to find the right coverage to meet your needs. Each policy has its own terms, conditions and requirements, which may necessitate action from you, your veterinarian and your insurance company.



TYPES OF COVERAGE

There are many types of coverage available to the horse owner and the conditions can vary widely between companies. Common types of coverage available for horses include but are not limited to:

- Mortality paid if the horse dies
- Loss of Use paid on a percentage basis if horse is permanently incapacitated for its intended use or purpose
- · Major Medical like health insurance, offsets costs of veterinary care
- Surgical policies which cover specific procedures such as colic surgery
- Breeding Infertility covers stallions or mares for reproductive failure
- Specified Perils includes any number of things such as lightning, fire or transportation

KNOW YOUR POLICY

Insurance policies are legal contracts between the underwriter (the company) and the insured (horse owner). To better safeguard yourself and your horse:

- Define your needs.
- Make a list of questions to ask your insurance agent or company.
- Read the contract thoroughly before you apply for coverage.
- Ask the insurance representative to explain any words, phrases or provisions you do not understand completely.
- Know your responsibilities. What is required should your horse become ill, injured or die?
- Understand any specific guidelines for emergency situations. A crisis is not the time to be trying to interpret your policy's fine print or to look for contact phone numbers.
- Discuss the renewal process with your insurance representative and understand what effect claims have on renewal, possible exclusions that result and how long these exclusions remain in place. Common claims may include colic (medical versus surgical), lameness, gastric ulcers, and other medical conditions.
- If euthanasia is recommended, know what steps must be taken in order for a claim to be valid.
- Comparison shop. Cost should not be the sole consideration, as buyers should consider the longevity and reputation of the agency and the insurance carrier, as well as their experience with horse insurance.

VETERINARY EXAMINATION

Equine insurers may require an insurance examination certificate signed by a veterinarian before a policy will be issued for a horse. Remember, this is a legal document, and your equine practitioner has an obligation to verify claims made about the horse through a thorough physical examination. A veterinarian cannot simply complete the requested information based on prior knowledge of the horse. This certificate requires that determination of the animal's health be made on the day of the examination. Cost of the exam and any associated tests are generally your responsibility as a part of requesting the insurance but the exact requirements of the exam may depend upon the type of coverage being applied for; for example, breeding infertility policy would require a different type of exam than a simple mortality policy, for example.

DETERMINING ROLES

A veterinarian cannot attest to the insurability of a horse. Your veterinarian can only respond to questions of which he or she has direct knowledge, reporting the medical facts to the best of his or her ability. He or she will be asked to positively identify the horse for which the application is being made. However, your equine practitioner has no role in determining the insurable value of a horse. That is a matter for the insurance underwriter and the owner to establish.

Do not expect your equine veterinarian to be an expert with regards to your insurance policy. If you have questions regarding your policy, ask your insurance agent or the company rather than your veterinarian.

If there is something that your insurance company requires, make sure your veterinarian receives the request in writing.

If a question or dispute should arise regarding a claim, it is a matter for you and your insurance company to resolve, as the insurance policy is a contract between you and your insurance company. Your veterinarian has no legal responsibility in the dispute.

EUTHANASIA

Euthanasia refers to the humane practice of ending a life to relieve pain and suffering. For an insurance claim to be valid, many companies require advance notification and prior permission except under the most extreme conditions. In some cases, the insurance company may wish to seek a second opinion before a horse is euthanized. The American Association of Equine Practitioners (AAEP) has established guidelines that state the justification for euthanasia should be based solely on medical, not economic considerations, regardless of the age, sex or potential value of a horse. The following criteria should be considered in evaluating the immediate necessity for intentional euthanasia of the horse to avoid and terminate incurable and excessive suffering:

- A horse should not have to endure continuous or unmanageable pain from a condition that is chronic and incurable.
- A horse should not have to endure a medical or surgical condition that has a hopeless chance of survival.
- A horse should not have to remain alive if it has an unmanageable medical condition that renders it a hazard to itself or its handlers.
- A horse should not have to receive continuous analgesic medication for the relief of pain for the rest of its life.
- A horse should not have to endure a lifetime of continuous individual box stall confinement for prevention or relief of unmanageable pain or suffering.

Learn what your insurance company's policies are regarding euthanasia. Are they in keeping with the AAEP's guidelines, and do they protect horses from prolonged or inhumane pain and suffering?

OTHER CONSIDERATIONS

- Know the time period for reporting any health problems to your insurance carrier.
- Determine if you must have prior approval for any elective surgery or medical procedures.
- Find out what documentation is required of you and your veterinarian in making an application or filing a claim.
- Understand situations that may preclude coverage of your horse, (e.g. is your horse covered when traveling out of state or out of the country?)
- Define for your veterinarian the purpose for which a horse is being insured, for example, as a performance horse or as a breeding animal. Additional comments or remarks on both health certificate and application are encouraged.
- Understand your financial obligations regarding veterinarian examinations, laboratory or diagnostic tests, necropsies or other procedures, which may be required by the insurer.

• Know the exact value of your policy and how it will be paid. For instance, a "loss of use" settlement might be different from a mortality payment if a horse is considered to have "salvage value." INDUSTRY INTEGRITY

You, your veterinarian and your insurance company each have a role in maintaining the integrity of the horse industry.

Regardless of insurance coverage, the horse's welfare must always be at the forefront of any decisions being considered on its behalf. For more information, contact your veterinarian.

The IRS Emphasizes Importance of Business Plans By John Alan Cohan, Attorney at Law

In recent years the IRS has ruled that a written business plan is important evidence tending to prove that you are operating in a businesslike manner. The Tax Court has said that in hobby loss cases you should have "some type of plan" for the venture. This applies whether you are involved in timber farming, horse racing or breeding, ranching, other farming activities, classic car refurbishing, multi-level marketing, antique collecting, boat or aircraft chartering, and other areas traditionally under IRS scrutiny.

The IRS takes the view that a written business plan demonstrates your businesslike concern for the success of the venture. People engaged in a hobby do not have business plans. One of the most important things that distinguishes a business from a hobby is the existence of a written business plan. There are numerous resources, some good and others not, to assist you in drawing up a business plan. It is advisable to have a business plan drafted by a professional, and the fee will depend on the complexity of the facts involved.



Keep in mind that a business plan is one of the best items of evidence to show your true intentions. The IRS Audit Technique Guide asks revenue agents to ask for a business plan in horse and livestock audits, and the absence of a plan is evidence that the taxpayer is not operating in a business like manner. In audits, most individuals are caught off guard when asked whether they have a business plan. Some will say that their activity is very basic, that they know what they are doing, and that they don't "need" a business plan.

What is a business plan? The business plan narrates what your business is all about, what kind of opportunity you see, and how you intend to make money. It is a guide for carrying forward your idea into a successful business operation. A business plan sets forth the overall market that you are targeting, and how your product or services compare with those of others. The length and breadth of the plan will depend on how much time you want to put into developing it.

The language of a business plan is usually simple and nontechnical. For many individuals, writing the plan is easy because of their prior experience in the field. For many, it is fun and creative. The main focus of a business plan concerns your marketing strategy and financial projections. You should narrate your market strategy, and state why you believe this activity can be profitable. You could include as an appendix copies of market information you have researched. You should also describe your competition and how you will be able to compete. You should set forth any competitive advantages that you have over other similar ventures.

In financial projections, you want to show how much money you will need to spend to get the business going, what equipment, inventory, and materials you will need to obtain, and when you expect to make a profit. There should be an indication as to your reasonable estimate of revenue. This is usually very difficult to project. Just do your best, perhaps with the aid of others experienced in the industry. Your financial projections of profit should be reasonable, not exaggerated.

Preferably, your financial projections should cover a three- to five-year period. Some people hire an accountant or CPA to help prepare the projections, as this can further bolster the businesslike nature of the document, although you will still need to spend time developing the figures. Most people project operating losses for the startup phase of the activity, which can be from three to seven years or longer, depending on the particular activity.

Prepare your business plan now: don't wait to get audited. It is too late to muster up a plan once you are audited. The IRS wants to see business records that are maintained in the ordinary course of your activity, not those that you might prepare once you have been notified of an audit. Ideally, your business plan will be written before you start the venture, rather than midway through it.

If you are audited and you don't have an existing business plan you should still prepare one, and admit that you have prepared it in connection with your audit. That is better than nothing. You can explain that the plan has always been in your head, and you thought it would be best at this time to reduce it to writing so that it can be clear how you forecast that this activity can be engaged in for profit.

Jay Cope, 1945 - 2011

Joseph Adams Cope, ASHA president for two terms, water rights and aviation attorney, and descendant of John Adams, passed away September 8 following his battle with cancer. Jay developed the idea that ASHA's annual meeting should include an Education Day so that there was value for every member who made the trip to attend the meeting.

During his first term as president, Jay realized that ASHA's bylaws, like those of many small non-profits, did not actually comply with the current laws of Washington, the state in which we are incorporated. He drafted new bylaws that would put us in compliance and then led the board through discussions of why we had to have (or didn't) various sections. Ultimately the version the board approved was submitted to the membership, and with few changes, serves us well today. ("Electronic mail," which was brand new and which Gene suggested we should all try, is barely mentioned – one of the few ways they're out of date.)

During his second term, when I was secretary, Jay supported obtaining the Heavy Horse software program so we could move from index cards and a typewriter to operating the registry and membership records using a relational database – another new term. We were the second registry to purchase the program developed for the Clydes, after deciding not to buy the Percheron program that required an IBM 3400 (for those old enough to know what that was).

Jay also contributed over \$70,000 in pro bono legal services to the association during the Wareing lawsuit. He and his late first wife Michele showed their Shires at National Western Stock Show, the national shows at LA County Fair in '84 and '88, at CO State Fair, and at numerous front range local shows. They hoped to have their beloved gelding Sam (Folly Farm Samson) cloned when the technology became available, causing ASHA to think about the registry implica-tions of cloning well in advance of most registries.

More than anything else, Jay was a wonderful friend and a true supporter of ASHA. He always put the horse ahead of the people, and understood that the organization is more important than any individual. He is survived by his second wife Susan and his sisters Sally and Penelope. *Charon McQin*

2011 All-North American Contest Update

The Shire All-North American Committee was recently notified by the Draft Horse Journal that "none of the other breeds could find common ground between sister organizations, so the Shires are the only contest we are taking on this year. The Clydes and Percherons are going to run the All-American themselves. The Belgians will just be doing their Merit Program. And the Canadians are doing their own thing as well. Not sure if that is a temporary situation, or permanent."

We look forward to ASHA and CSHA working together on this prestigious event. Please contact the committee for further information and questions. Nomination forms will be posted on-line soon.

Eligibility in the All-North American program is determined entirely by placings at the designated shows listed on the next page. The top four Shires in each class at AA level shows, the top three at A level shows, the top two at B level shows and the class winners only at C level shows are eligible to be entered in the All-North American Contest. The horse must earn a qualifying placing in the open class at one of the recognized shows. Placings in bred & owned, futurity or other specialty classes do not qualify. Qualifying placings are the official class placing only, regardless of breed, age or sex eligible to enter the class. For example, in a mixed sex foal class, a stallion foal placing 2nd behind a filly would not qualify as the 1st place stallion foal. Likewise, a Shire placing 2nd in a mixed breed class behind a Clydesdale would not qualify as the 1st place Shire. All nominated horses must be <u>DNA verified and registered</u> with the respective breed association. This includes foals and geldings. CSHA, ASHA,

and SHS registered horses are eligible. Membership is not required.
