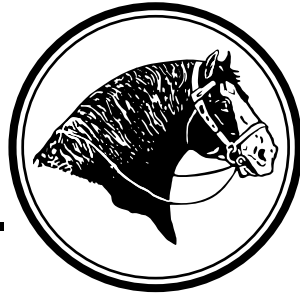

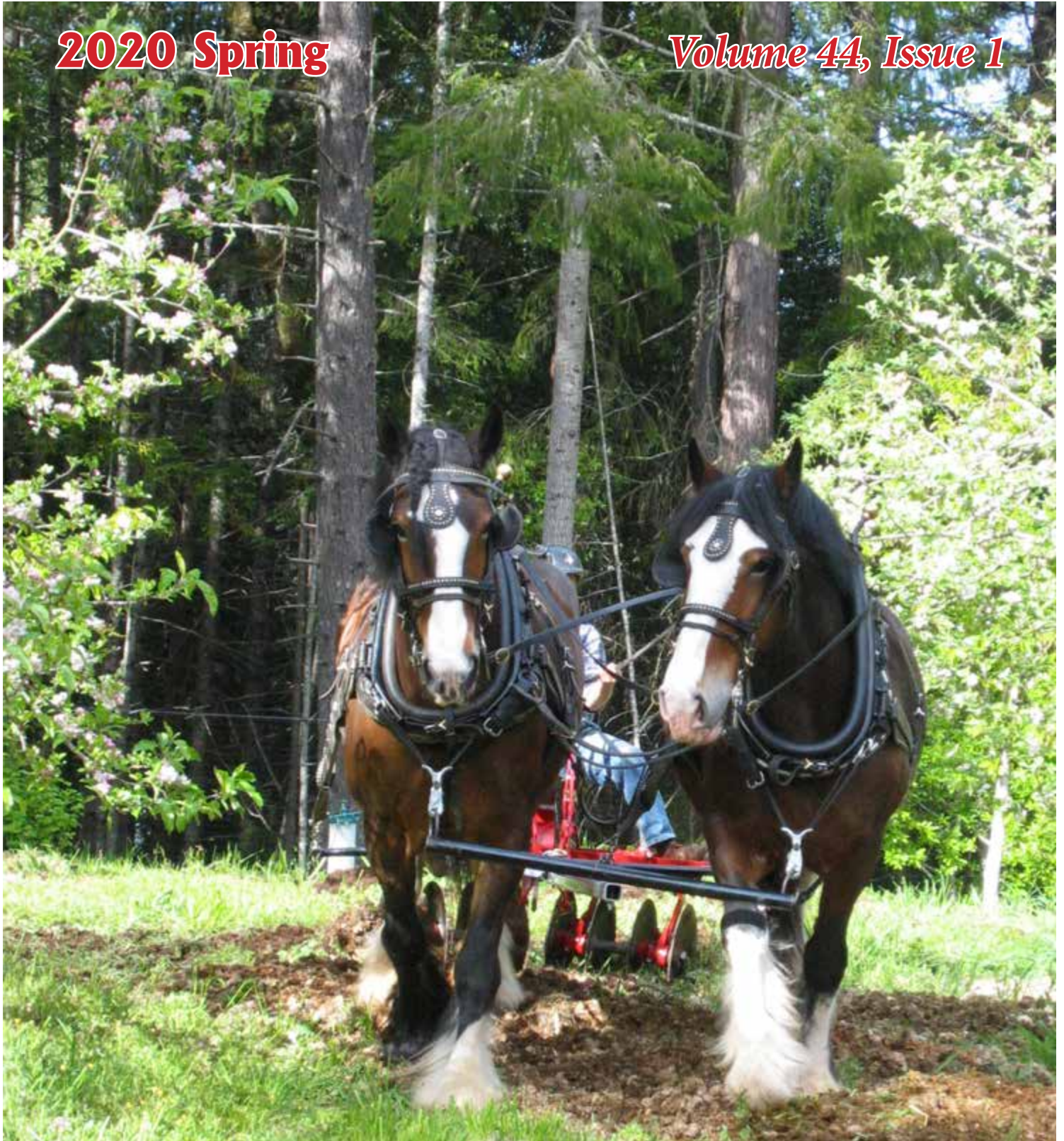

I'd like to address an issue that seems to be reoccurring with registering and transferring horses. It is the responsibility of the breeder/seller to complete all registrations and transfers—we are experiencing too many instances where a horse is sold that has not been registered OR the new owners are handed registrations or transfer forms that are filled out, but have not been sent to the office to register. Many times, this paperwork falls to the way and we (ASHA) not only lose these horses from our records, but it causes a domino effect when the horses are older and produce offspring. We request that when you sell a horse, the seller completes the paperwork and submits to our office. We also have discounts in place for registering your horses in a timely matter, if you have any questions, please feel free to call me and I will help you. Another issue that seems to be continuing is breeders not providing the description of their horse on the registration paperwork. It is not our Secretary's responsibility to do this, if no description is listed, that will reflect on your registration.

I'd like to thank all those who joined us in Springfield, Missouri for our Annual Meeting. We were able to have a great education day program at Soaring Eagle Farms, with Dr. Jeff Gower and Glen/Shelley Lewis family. A RENAISSANCE MAN

A Renaissance person is described as a person with a yearning for knowledge in physical, intellectual, artistic, and social fields and who develops deep expertise in some of them. Charles Perry Andrews, Jr, of Hideaway Pond Shires was one of these people. He was born November 10, 1924 and died on July 15, 2019 at the age of 95 in Manassas, Virginia. He was a veteran, a pilot, and drove race cars. He loved the opera, the Capitals hockey team and was proud of his Scottish heritage. He studied philosophy and religions, reading books all the time. He traveled to England when in his 70's to take classes at Cambridge University. On one trip he met the Dalai Lama. He did a lot of volunteer work and was an active member and officer of the Manassas Lions Club. He helped open a museum, served on a hospital board, and he actively supported his family members and extended family with love and advice. He was a past member of the Virginia Draft Horse & Mule Association and a Lifetime member of ASHA. He had developed dementia in his latter years, but he always looked forward to receiving and reading our ASHA Newsletter. Perry lived a long full life.

Many newer Shire owners may have never heard of Perry and his wife Betty Andrews, Hideaway Pond Shires, or know of their contributions to the Shire horse in America, but Perry wanted to leave a legacy and cared deeply about the Shire history and about the future of the Shire Horse.

In 1989 Perry asked Arlin Wareing to accompany him to England to look for a stallion to begin his breeding program. After visiting many farms and looking

at many Shire stallions, they arrived at Garreg Farm in Wales. Perry eyed a nice looking 18-month-old stallion, and knew he was the

one, and inquired on a price for him. The breeder, William J. Davies really was not keen on selling this colt, as he had hand raised him, and named the colt William, after himself, but Perry was persist and Mr. Davies finally agreed to sell his colt, Garreg William, who was out of Metheringham Stormer and Iddon House Black Jewel.

When Garreg William was to be imported to America, he was loaded onto the plane 24 hours before takeoff, and when he arrived, he was very dehydrated and looked poorly, but when Perry arrived to get him off the plane and William saw him, he brightened right up.

Perry purchased his foundation mares from the Parrington family (Tally Ho Shires) to complement Garreg William's qualities and Hideaway Pond Shires became real. Hideaway Pond's foals were usually sold immediately, and Perry and Betty usually produced three to four foals each year, but some

years Perry gave the mares a break.

In 1991, when Perry was 67 and having had one heart attack, he realized that he would not always be able to continue breeding, and he knew he would sell Garreg William while William was still in his prime. Perry was interested in artificial insemination and researched it extensively, finding no Shire breeder using the process at the time. When he decided he wanted to take William to have him collected, he contacted Jim Crump, who along with his wife Julia started Roanoke A. I. Laboratories, Inc. in Roanoke, Virginia, in 1984.

Jim graduated from Virginia Tech in 1971 with a major in Chemistry and a minor in Biology. He then attended the Medical College of Virginia, receiving his BS in Pharmacy in 1973. He used this knowledge to formulate and prepare semen extenders and improve techniques for collecting and freezing stallion semen. He was one of the first to begin using ½ milliliter straws, which is an industry standard today. In 1978, Jim developed the Roanoke Model Equine AV for collecting light horse stallions, but it has since proven successful on a wide range of stallions, from ponies and zebras to Shires.

Perry took William to Roanoke AI to be collected on May 16, 1992 and again in July, that same year. He would take William several more times in 1994 and 1995. William had good fertile semen and it froze well.

William's first offspring born using his frozen semen was Cambry Dee, a filly born in 1994 to Iron Slipper's Misty Rose. He continued to make a positive impact on the modern-day Shire, by producing 42 registered offspring; 14 stallions, 26 mares, and 2 geldings, with 16 of those offspring being born after his death on February 27, 1997.

William produced several National and Canadian Grand Champions, with his first being Illusion Farms Mister Sampson, a stallion born in 1994, out of Country Roses Felicia, he was National Grand Champion in 1996 and 1998. Sampson would produce 25 offspring, several being champions as well.

William had many other stallion offspring that influenced the Shire breed, also producing many champions, including his only gray, Illusion Crystal Clear of Ox Kill, born in 1997, with 26 offspring; D & J's Moose, born in 1998, with 14 offspring; Hideaway Pond Prince William, born in 1998, with 7 offspring; Sassy Supreme Prince William, born in 1998, with 23 offspring; and Duke's Cinco De Mayo, born in 2000, with 9 offspring.

William also had several of his mares that were champions, including Hideaway Pond Aurora, born in 1997, she was National Grand Champion in 1998, and Hideaway Pond Coppelia, born in 1998. Coppelia beat out her full sister Aurora to take Canadian Grand Champion in 2000.

Other William mares that have contributed to the Shire breed are Hideaway Pond Calliope, born in 1993, who produced stallion, Black Forest Windchime John, born in 1999, who produced 9 offspring, and Grandview Lady Shanno, born in 1999, who produced stallion, Illusion Farms Tuff Hedeman, born in 2005, who produced 25 offspring.

Garreg William currently has a total of 323 registered progeny. Of the 323, 192 were born after his death in 1997. Had it not been for Perry thinking ahead and taking William to have his semen collected and frozen, these births would never have been possible. Though William had no show record of his own, he did place first out of 5 entries in Get of Sire at the 2000 National Show, and placed 6th out of 8 entries at the 2003 National.

Perry and Betty Andrews opened the door for Shire breeders and now artificial insemination with frozen semen is a standard practice, allowing Shire breeders to obtain semen from stallions world-wide, if they wish to do so.

Perry's friends and family will miss his humor, his take on life, and his great kindness. Their veterinarian constantly told him that sugar was bad for his horses, but Perry and Betty bought jellybeans out of the giant barrels at the grocery and every morning and evening at feeding time each horse got three. He would say "Their eyes and their faces tell me everything I need to know about the Shires."

IN MEMORY OF HOUSTON P. HAUGO



Houston Haugo, lifelong banker, entrepreneur, and true cowboy at heart, died December 11, 2019 at the age of 77, after bravely battling Type 1 Diabetes for over 50 years.

Houston Pierre Haugo was born on March 19, 1942 in Sioux Falls, SD to Erling and Clara (Thompson) Haugo, who made sure he was a South Dakota boy from the start, bestowing a middle name after our capitol city. Born into a busy household bustling with community, business and politics, Houston loved growing up across from Mark Twain Elementary and soon became a politician himself becoming class president at Washington High school and graduating in 1960. He attended the University of South Dakota in Vermillion where he met his future bride and the love of his life, Judith Anne Macy. Houston and Judith were married January 1, 1966 at First Lutheran Church in Sioux Falls, SD. In 1970, he graduated from the University of Colorado School of Banking.

They started their marriage living in Vermillion with Houston working for Valley State Bank in Yankton, SD. Houston and Judith moved back to Sioux

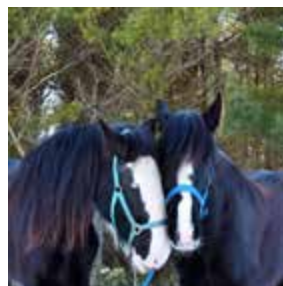
Falls while Houston continued his career with Valley National Bank. After the family sold their banks in Sioux Falls in 1988, Houston branched out with his own banking operation, Valley Banks of Elk Point, Jefferson, and North Sioux City. In 1992, he proudly reopened a Valley Bank in Sioux Falls. Houston loved banking. And he loved his Valley Bank family, both customers and employees. In 2008, with a heavy heart, he sold the banks and ended an almost 5 decade career in banking.

In 1982, Houston partnered in starting the legendary radio station 95.1 KSKY in the Black Hills of South Dakota. In the 1990's, he and his son Chris expanded the company to become Haugo Broadcasting grew the station group adding KICK 104 and KTOQ in 1998. In 2017, they purchased HITS 102.7 from Pandora Media.

Houston had a huge heart and was a generous and charitable community member. Both through his business and personally, he supported many organizations through his life including Shriner's Hospitals for Children, Tocqueville Society of the Sioux Empire United Way, Juvenile Diabetes Research Foundation, Salvation Army, Lifescape, and the Dakota Royal Charity Draft Horse Show to name a few. He created the Houston Haugo Family Foundation with the Sioux Falls Area Community Foundation, and was proud to support many other charitable organizations. He was a member of Kiwanis Club and El Riad Shrine. Over his life, he served on many boards including various banks, Luther Manor, Sioux Valley Hospital, Independent Community Bankers Association of America, and the independent Community Bankers Association of South Dakota. He also served as a Lincoln County Commissioner.

Houston was a lifelong horseman, inheriting the love of horses from his father, Erling. Over the years, he owned many horses, including Tennessee Walking horses that he showed in competition. Later in life, one of Houston's proudest achievements was creating the Dakota Thunder, a draft horse hitch team made up of the world's largest horse breed, English Shires. Houston and Judith celebrated their 50th wedding anniversary by riding with the Dakota Thunder Shire team in the 2016 Rose Parade. Dakota Thunder achieved the National Championship for Shires and many other great achievements in the Draft Horse world.

Houston is survived by his loving and devoted wife Judith, daughter Alison (Dan) O'Neill; son Christian (Jill) Haugo, granddaughters Caroline and Catherine Haugo all of Rapid City, SD, only brother Roger Haugo of Sioux Falls, SD, Very special brother-in-law and sister-in-law Bob and Ginny Macy of Yankton SD and many nieces and nephews. He is preceded in death by his parents.

1. **Call to order** – President Wayne Wareing called the meeting to order at 8:03 PM EST

2. **Roll Call:** Karla Stoner

3. **Approval of previous meeting minutes**

- 2019 Q4 BoD teleconference – Karla thanked Sharon for her proofing and corrections of the draft 1 meeting minutes. Changes sent out to the board in draft 2. No other changes received. Requested board approval for draft 2 minutes. Sharon / Audrey-Lyn moved that the board approve the draft 2 minutes of the Q4 2019 teleconference. No discussion. All in favor.

- Free Conferencing Transcription services – Karla reviewed the information from Free Teleconference.com which was sent out in an email after the last meeting (October 14, 2019. Text of that email is copied below for the record: 'I checked with Free Conferencing and we are not currently setup for transcription. The recordings can be (and are) downloaded, but are not transcribed. We can step up to include transcription along with a number of other options if we choose to do that. My understanding is this will all still be free, but I'm looking into the details. I did want to point out that it is sometimes very hard to hear what people are saying on the recordings, mostly due to phone connections, I think. This could also cause problems with transcription. A few years ago when we had transcription service for the voice mail on the office phone, there was a large problem with this and we gave it up. Not sure technology has improved enough yet.'

4. **Additions or deletions to the agenda** – no changes, but Wayne asked to move to the Financial report since Stacie was not on the call yet. Asked Lisa to contact Stacie to see if she had time to call in. Dean asked to move to other business first.

8. **Other business**

- Open board member position – status – Wayne reported that he was a little behind on this due to health issues, but had talked to some members and will follow up. Karla reminded the board that in the past an open position on the board in an election year had been left unfilled until the election and could be again. The subject will be addressed at the annual meeting.

- Annual meeting plans - Lisa reported that everything is in the works. There will also be an all draft breed registries meeting prior to the ASHA meeting. The Clyde assoc. will be hosting some details of this and appreciated ASHA taking care of the meeting arrangements. It will start Wednesday evening (02/12/2020) with a dinner close to the hotel. The meeting will be at the hotel on Thursday, 02/13/2020).

- § Friday, 02/14/2020 will be an ASHA board workshop / meeting at the hotel. Stacie will have an information pamphlet available for the board & members to review.

- § Saturday will be an education day and members meeting at Dr. Gower's Soaring Eagle Farm with a catered meal (farm is about 4 miles from the hotel). Transportation to be arranged.

- § Sunday will be further ASHA board meeting at the hotel, as needed.

- § Airport is not far from the hotel. Contact Lisa for transfer arrangements.

- § Lisa thanked Sharon for her help with the hotel contract, getting an announcement in the newsletter and sending out postcards to the membership.

- § Lisa will put updates on facebook as well.

- Archives update – Karla reported that there had been some interest from the newsletter ad for the VHS tapes from a Canadian member and shipping arrangements are in progress. Requested info to be posted on facebook as well, will get together with Charity on that. Jim asked if anything could be brought to the annual meeting. Will get together with him on that.

- Records of BoD electronic votes – Karla asked if someone was keeping records of any electronic (email) votes the board makes between regular board meetings. Dean said there was one to approve Danelle to the board and one other. Wayne and Karla will get together on those.

- Meeting minutes archives – Karla – last check there were no meeting minutes posted on the website, including all earlier years. Does the board still want to do that? Charity said with revamping the website a lot of things have come down, including the by laws. She and Stacie are working on what should go on the ASHA Site and what on Digital Horses. Will have a proposal for the annual meeting. In the mean time send Charity anything that needs to be put up. All archives are on the Digital Horse side right now.

5. **Secretary's report** – Stacie Lynch had not been able to get a report out prior to the meeting, due to other demands on time. Will email report ASAP. Emailed it on 01/08/2020. See Attachment 1.

7. Financial Report – 2020 budget Dean / Stacie

- Dean reported that Audrey-Lyn has been working with Stacie on some problems with the Quick Books program communicating with the Digital Horses program. Hope to have glitches resolved shortly.
- Dean reported he had not had any response to his request for budgets from committee chairs. Danelle is the only one he has heard from and needs input from the others. Charity and Karla said they had sent their requests to him by the date he requested. Dean will recheck his email, as he has been having some problems with it. He asked to have the emails resent.
- Dean plans to have a preliminary budget to the board by the 15th of January so there is time for review before the meeting. Will have it in an excel format so it can be modified at the meeting. Wants to have the budget set at the meeting so everyone knows what's going to happen. Sharon requested getting information at least a week in advance for anything we need a decision on.

8. Cont'd - Back to Other Business

• Dean asked if the Rules Committee was working on outlining any rules changes needed for merging with the Digital Horses program. Will there be anything before the board meeting so there can be some time to review? Karla reviewed the list of tentative agenda items sent out to the board in December (Attachment 2). Dean said he had not received that email either. Tom reported that any changes needed would be ready for discussion before the annual meeting so they can be finalized for a membership vote (digitally, so it will go quickly). Tom also reported he had someone interested in the vacant board position if he (Wayne) wanted to follow-up.

• Membership renewals that have not come in yet. Stacie reported that 84 members have not renewed yet. Reminders have gone out via email (using Percheron account) and the ASHA newsletter.

§ Charity: we have had some reports of issues with authorize.net on the ASHA side – conflicts with authorize.net on the digital horse site? Charity suggested the board make some decisions at the meeting on what they want hosted on each of the two websites. Need to streamline things and educate the members. Incorrect email addresses may be part of the issue. Need to be updated.

§ Dean what about sending out postcards as next step to remind people? Tom: suggest waiting to see the response from the newsletter reminder and try email again.

§ Charity – sending out emails and postcards – need to use ASHA mail chimp and ASHA needs some kind of push with the membership to update email addresses. Stacie is not being paid to mail out emails or postcards. Stacie has a list of non-renewals she would be happy to send out. Charity volunteered to take it and follow-up.

§ Audrey-Lyn – postcards have more than paid for themselves in the past. If emails have not worked to date on the non-renewals, a change in tactics should be considered.

§ Karla volunteered to send out postcards. Stacie; Try email again. If that doesn't work, try calling. The Percheron Assoc. has had better luck with phone calls. Break it up among the directors.

• Lisa Graham – Item for National Show – ISF will be hosting the National Clydesdale Show again in 2020 and CBUSA has asked for additional riding classes with no entry fee or premiums (ribbons only). Does ASHA want to consider similar classes to encourage other Shire owners to participate?

• ANA – Travis is resigning as chair of ANA due to other time demands. Stacie has programs that are inexpensive and may be very helpful with the workload. Consider at annual meeting.

• Charity – Annual meeting question – do we need to bring our projector? Lisa didn't know for sure, but suggested they bring it. Can discuss with Stacie.

• DJ Bradshaw - reported that as a member of the rules committee he has been phoning members without email addresses, to see if they have them or can get them signed up for access to Digital Horse and electronic voting. A few say they will not get an email address, no matter what, but he also found a lot of bad phone numbers and suggests the board work on getting these updated.

§ Dean asked where the list he was using came from – Charity said she sent him one from December 23, 2019.

§ Stacie – of the 84 non-renewals only about 5 don't have email.

§ DJ – Still felt the board needs to look into updating contact information.

9. **Adjournment** – With no further discussion, Wayne asked for adjournment. Sharon / Dean moved to adjourn the meeting. Meeting adjourned at 8:40 pm EST.

Shire Horse History In America

Chapter 6

Please note: This work is an excerpt from a larger book with earlier installments in previous newsletters and is to be taken as the opinion of the author.

I cannot do justice to the impact of two world wars in a few paragraphs, the devastating impact on both people and horses. This is a turning point in the history of the Shire and literally brings us back where we started in many ways. The Shires' predecessors came to England through various invasions and steadily grew in numbers as the country settled into years of prosperity, but the advent of World War I in 1914 strained every resource possible.

The next step is to go back on our historical timeline and examine the first Shires to be imported to the United States. Exportation was happening to many countries, including Canada and Australia, but we will follow the genetic line to America and come current to the end of World War II to begin discussing the relationship that was re-established with England and ultimately saved the breed in both countries.

The invention of the combustion engine and its application to cars, trucks and tractors in the early 1900's is often blamed for the dwindling number of draft horses. While this did have an impact over time, a greater one in the United States that we will discuss later, it was in fact the two world wars that destroyed the greatest number of horses in the shortest amount of time in Europe's history and the population of Shires has never fully recovered.

Sir Walter Gilbey, the first president of the Shire Horse Society, died at the age of 83 in the first year of World War I. That same year, Francis Egerton, the third Earl of Ellesmere, died and the estate was turned into a Red Cross Military Hospital during WW I, and then during WW II the land became a military training ground. The Shire breed not only lost major supporters, but the very ground they were born on.

World War I had a devastating effect on the people, the government, and the horses worldwide before it ended in November of 1917. A third of the large estates in England were gone, many more soon followed in the economic crisis that followed. The English sent over a million horses to war and 484,000 were killed. Approximately eight million horses were killed overall, most of which were the heavies used on the front lines moving armaments and supplies. Over 7,000 were killed in one day at the Battle of Verdun.

The army retained some of the horses that survived, but the majority were either given to the local farmers or slaughtered for human consumption. British farmers were compensated by the government for the horses and farmers parted with them willingly to support the war, but they also needed their horses to make a living; it was quite common to hide some of their horses when the government buyers came around. One of my good friends, Delma Nulty, told me her forefathers' kept a team hidden

in the woods along the river that ran through the farm. Those horses survived World War I and continued the breed, though four years of war had nearly depleted the population.

As the commercial working horses died or needed to be replaced there were fewer horses available, and other means were used to carry on the business. Bruce Roy; Canadian Percheron breeder and Historian of the breed relates the fact the Percheron numbers in England were so depleted, George Lane, owner of the Bar U Ranch in Alberta, Canada (one of the four men who started the Calgary Stampede) exported 50 head of Percherons to England in 1919. Those, coupled with some acquired from the French government, were used to rebuild that breed.

As we have discussed previously, only a small percentage of Shires were included in the registry compared to the number that likely existed, thus they only made up a small amount of the war horses that can be traced. I have been told, but cannot prove, that the government buyers were more inclined to buy from the tenant breeders than the elite estate owners. Some said the small farmers had better horses, but regardless of the reason the small farm and commercial horses suffered the biggest loss. The need to rebuild animal horse power was overshadowed by mechanical horse power and we begin to see the impact of the availability of the combustion engine. The percentage of horses in the Shire registry seemed to increase, but the overall number of draft horses continued to drop. The Liverpool docks are a good example, during the early 1900's over 20,000 horses were used daily on the Liverpool docks, by 1935 that figure dropped to slightly over 4,000. In 1950 there were none.

In 1938 only 304 stallions were registered, and 1,102 mares were registered in the Shire Horse Society. There was no chance of recovery when World War II broke out in 1939 and the remaining horses were called to duty. The cavalry divisions were largely gone, but draft horses were still used on the front lines to move men and equipment, especially by the German and Russian armies. Any chance of recovering exported breeding stock was ended as thousands more horses died in battle.

The English contributed approximately another 6,500 horses that did not return. By the end of World War II in 1945, there were very few horses left in the world, let alone draft horses,

compared to 1900. The farmland throughout Europe was all but destroyed from battle and would take years before it was suitable for crops. It was difficult to keep the surviving population of people fed let alone support livestock with fields dedicated to hay production. The number of Shires registered with the Shire Horse Society continued to drop until 1958, when a total of only 29 were registered. A few years after Roy Bird became Secretary in 1963, he estimated there were less than a thousand Shires left in England.



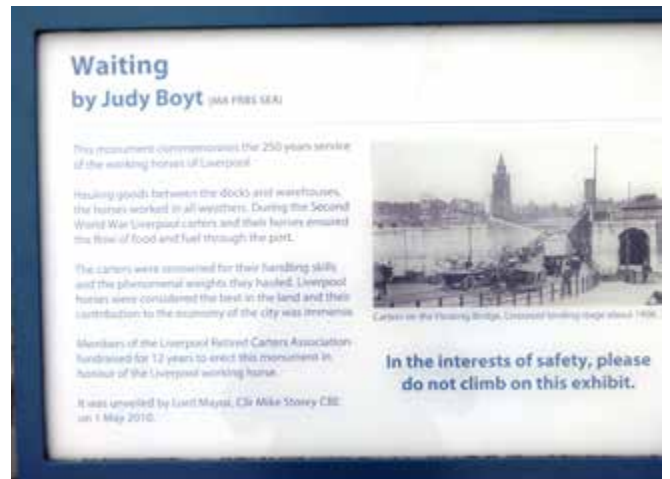

Waiting

- Sharon McLin / Audrey-Lyn moved the board accept Kim Murchison's offer to develop a new breeder's brochure, similar to prior versions. To be paid for by ads and brought to the ASHA board for approval prior to printing. No further discussion. All in favor.
- Audrey-Lyn Stockton / Dean Jenson moved to identify Digital Horses as ASHA's official studbook. After a brief discussion, all in favor.
- Tom Greenlee / DJ Bradshaw – moved to allow ASHA sharing our studbook information with everyone. After a brief discussion, Audrey-Lyn called the question. Not accepted. After further discussion, DJ Bradshaw called for a roll call vote: Jim Paulson – no, DJ Bradshaw – no, Audrey-Lyn Stockton – no, Tom Greenlee – yes, Danelle Kinney – yes, Sharon McLin – no, Clark Jenson – no, Dean Jenson – no. Motion defeated.
- Sharon McLin / Audrey-Lyn Stockton moved to change the wording under the (stallion breeding) report to make them mandatory and free, if filed electronically or postmarked before 01/31 of the year after the breeding, with a \$25 fee to amend the report after that date. Motion tabled for further discussion.
- Audrey-Lyn Stockton / Tom Greenlee moved to approve the Q1 2020 quarterly board meeting minutes as amended. All in favor.
- Sharon McLin / DJ Bradshaw moved that effective with the 2020 breeding season, stallion reports shall be mandatory annually. Such reports shall be free if filed by 01/31 of the following year, with a \$25 fee if late or amended after that date. All in favor.
- DJ Bradshaw / Sharon McLin moved that ASHA allow member information to be viewed by the public on Digital Horses and in the future, with option for members to opt out and the ASHA board to address any policies / forms to come in line with the opt out policy. **EXCEPTION:** Youth member information shall not be public. All in favor.

Financial Motions

- Audrey-Lyn Stockton / DJ Bradshaw moved to accept the 2020 budget as adjusted. All in favor
 - Audrey-Lyn Stockton / Sharon McLin moved that USDF participation be self-funding.
 - Audrey-Lyn Stockton / Sharon McLin moved that ASHA survey the members as to whether they would like to receive the newsletter digitally. (cost reduction) After some discussion the topic was referred to the Media Committee.
 - DJ Bradshaw / Sharon McLin moved to require all requests for money for future funding (next fiscal year) be in by September 15th of the current year. All in favor.
 - Audrey-Lyn / Sharon McLin moved that the treasurer and assistant treasurer decide on priorities of bills to be paid, depending on cash flow and budget. All in favor.
 - Audrey-Lyn Stockton / Sharon McLin moved that the treasurer be able to open bank accounts as needed. Motion carried.

All in favor. (During discussion, the board clarified that under our current rules the Canadian or Australian transfer to the new owner(s), if applicable, must be processed prior to ASHA registration. ASHA is allowed to process SHS transfers to the new owner(s) during the ASHA registration procedure for an additional fee.)
- Tom Greenlee / DJ Bradshaw moved that, co-ownership signature authorization will be sent to the office to designate who can sign for transactions. All in favor.
- Tom Greenlee / Sharon McLin moved: as of June 1, 2020, Section X.D. of the ASHA Registration Rules shall be changed to read: If a member and non-member jointly own a horse, non-member fees shall apply. Motion Carried.
- Audrey-Lyn Stockton / DJ Bradshaw moved that as of June 1, 2020, Section VI.C. of the ASHA Registration Rules shall be changed to read: For transfers, all parties to a transfer (seller[s] and buyer[s]) must be members to enjoy member-rate fees, Motion carried.
- Tom Greenlee / DJ Bradshaw moved that as of June 1, 2020, there be a new rule that no registration or transfer can go more than 90 days without completion or all fees will be forfeit and the process will have to start over. All in Favor.
- Sharon McLin / Audrey-Lyn Stockton moved that as of June 1, 2020, Section I.B. of the ASHA Registration Rules shall include the following sentence at the end: '...time of foaling). If anyone other than the recorded owner of the dam at the time of foaling sends a registration application to the office, the recorded owner of the dam at the time of foaling shall be assessed a penalty of \$100.' All in favor.
- Tom Greenlee / DJ Bradshaw moved to adopt the Percheron Horse Assoc, fee schedule for transferring ownership of a horse. After some discussion, motion withdrawn.
- Tom Greenlee / Audrey-Lyn Stockton moved that as of June 1, 2020, if a horse is not transferred within 30 days of the sale, the transfer fee will double. All in favor.
- DJ Bradshaw / Tom Greenlee moved: in Registration Rule VI. A. Transfers, insert '. by the seller' after 'submitted...'. (VI,A. A transfer application shall be completed and submitted by the seller, with the appropriate fee, upon every change of ownership of a registered horse when the seller wishes to change the owner of record.) Effective June 1, 2020. All in favor.
- DJ Bradshaw / Audrey-Lyn Stockton moved: in Section VI.F. of the registration rules, change 'may' to 'shall'. 'The recorded owner of a stallion or frozen semen may shall file a Notice of Frozen Semen Transfer with A.S.H.A. when selling multiple units of frozen semen to a buyer.' Effective June 1, 2020. All in favor.
- Jim Paulson and DJ Bradshaw moved to reduce the lease fee to \$10. Motion carried.
- Tom Greenlee / Dean Jenson moved to allow DNA case numbers to be visible only to owners in the Digital Horses program. All in favor.

On December 14, 2017, a group of scientists made history in the world of therapy horses. The Journal of Equine Veterinary Science published "The Effects of Equine Assisted Therapy on Plasma Cortisol and Oxytocin Concentrations and Heart Rate Variability in Horses and Measures of Symptoms of Post-Traumatic Stress Disorder in Veterans." This ground-breaking research gave us scientific support that horses are not affected negatively by participating in Equine-Assisted Activities and Therapies (EAAT).

Electrocardiogram telemetric heart rate monitors specifically designed for animals were used to record the Heart Rate Variability (HRV) of the horses 5 times during 3 of the 5 therapy session days.

Blood Cortisol concentrations and oxytocin levels were taken via blood samples as indicators of stress. Blood samples were taken 30-minutes before each therapy session while the horse was at rest, immediately before the therapy session, 10-minutes after the 1-hour therapy session ended, and 30-minutes after the therapy session ended.

The HRV is measured because it physically reflects the emotional state of the horse. HRV measures both the high frequency (HF) power and low frequency (LF) power. The HF measures the parasympathetic nervous system and the LF measures both the sympathetic and parasympathetic. During times of emotional stress, the HRV will respond with the sympathetic increasing and the parasympathetic decreasing. Negative feelings increase the sympathetic; positive feelings will decrease the sympathetic and increase parasympathetic.

Cortisol is measured because it is a hormone that indicates emotional stress. It is secreted as a result of the sympathetic experiencing negative feelings. The more stress, the more cortisol in the bloodstream.

Oxytocin is an indicator of positive feelings. The presence of Oxytocin increases the parasympathetic by reducing the stress hormones in horses. The more positive the horse feels, the more Oxytocin in the bloodstream.

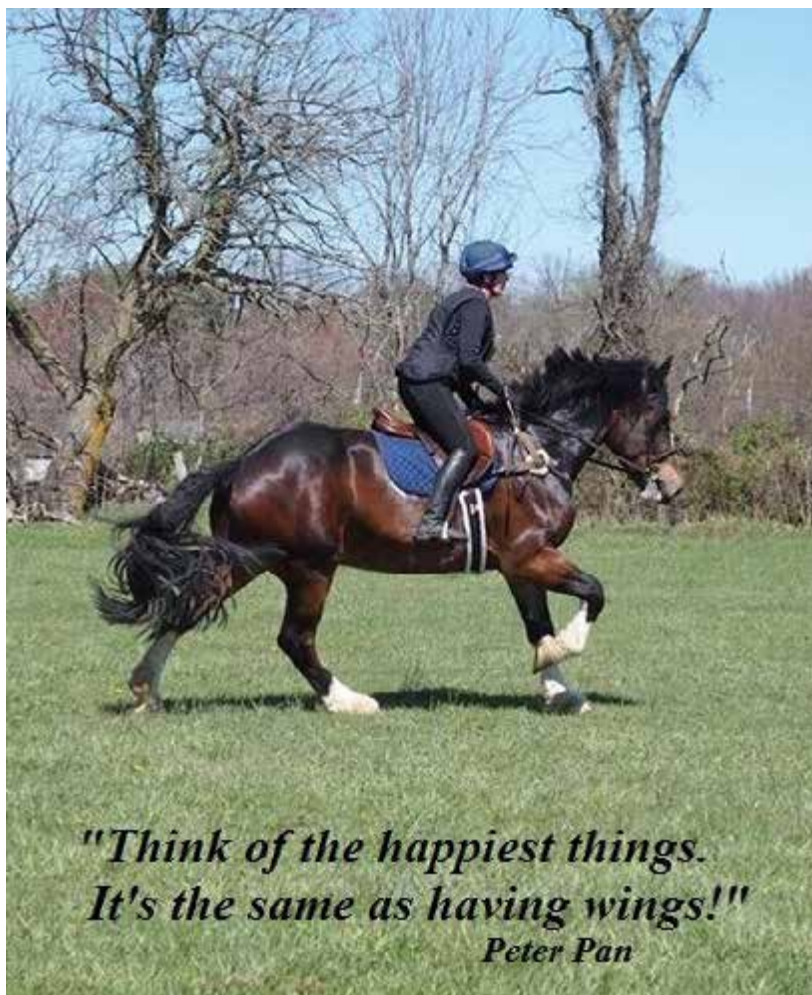
The results were amazing:

- "Stress levels, as demonstrated by plasma cortisol concentrations, and HRV, did not change in horses involved in EAAT sessions with veterans who had been previously diagnosed with PTSD."
- "We found no changes in plasma oxytocin concentrations in horses involved in EAAT with veterans."
- "To our knowledge, this is the first report of the measurement of oxytocin in horses used in EAAT programs."

These results not only give piece of mind to horse enthusiasts, but the Professional Association of Therapeutic Horsemanship (PATH) can now feel total relief knowing the horses they are utilizing during their PATH session are not experiencing negative physical affects as a result of their involvement in the therapies.

NOTE: Jenni M. Tevlin, a Shire Owner, was involved in the research. It is because of her that I was introduced to this study so I could share it with you!

ARE YOU AND YOUR HORSE RESCUE READY?

We're into horses and we're well aware horses are a prey species. Their inherent trait of "fight or flight" is their basis for survival. As hard as we try, there are some things we can't protect horses from, or prevent them from instinctively reacting to. Trailing accidents, fires, ice, floods, mud, and deadly storms are just some of the dangers our horses could face no matter how much we safeguard them. With that in mind: is your equine companion ready to be rescued? Will he trust you, another person, a fire-fighter, or someone else, in the event of an emergency?

Over the last decade I've taught dozens of Large Animal Emergency Response (LAER) programs across the US and into parts of Canada. When it comes to a successful rescue, the owner plays a big part. The better practiced and prepared an owner and horse are to be rescued, the better the outcome of the incident. Unless a horse learns and trusts to submit to someone trying to help, the chances of rescuing or saving them from threats are limited. With those thoughts in mind, the task begins: educating horse owners to get their horses "rescue ready".

If your horse is involved in an emergency incident in most of the US or Canada, there is an excellent chance the responders answering your call will know what to do for scene safety and vehicle stabilization, but they will only have limited knowledge on how to help your horse. You, as the owner, maybe the only one who can bring "the animal component" to the incident. You will probably be the only person on scene that your horse knows. Staying calm no matter how traumatic the event is, and communicating calmness to your horse, will help your horse relax as much as possible and, in turn, help responders mitigate the situation.

One critical element that enables a successful outcome involving an animal incident is the initial 911-call for assistance. While GPS may automatically know the location, always post your E911 location numbers for your address at areas easily seen from the road. Additionally, always ensure whoever places the emergency call informs the dispatcher, and in turn the responders, that large animals are involved. A veterinarian may or may not be requested or available. Not all dispatch centers have knowledge of veterinarians who will respond to large animal incidents.

Responders who have had LAER training will know to respond without lights and sirens. It's acceptable to ask that these be silenced en-route and certainly when in the area and on scene. Apparatus should also be positioned so as not to disturb the animals further. Professional responders will accommodate these requests and ensure that other responding units keep any negative stimuli to a minimum. If it can be safely accomplished, placing a large wad of gauze or cotton ball (carried by all ambulance crews) in the horse's ears will deaden the effects of loud and unfamiliar noises.

A fully trapped horse, as well as most other animals, will not struggle unless they sense freedom. Unless immediate safety dictates such as in the case of a trailer or attached vehicle fire,

do not open doors of a trailer that holds an animal. Even in the worst of circumstances, many horses sense their trailer as security and safety. If possible, cover the windows with materials to darken them. If removing the horses or animals is necessary, attaching a rope and halter to a trapped horse will enable a safer release of the animal.

Plan for and ensure a containment area is set up before any animal is released from a trailer or entrapment. This can be attempted with vehicles parked in a circle around the incident, by using ladders off fire apparatus, or possibly temporary fencing from a local construction site. This is particularly important for horses extricated from trailers along highways, or for animals that have escaped from their enclosures and have become trapped in mud, trees, rocks, ravines, or other obstacles. DO NOT enter, or allow anyone else to enter, a trailer or an area with an animal that is trapped or struggling. Wait for a veterinarian or owner to administer tranquilizers, and use tools to extend your reach to assist or medicate the animal.



Thermal Imaging

Thermal imaging cameras, readily available with most fire departments, are also handy for locating lost or wandering livestock. These cameras sense heat and can locate warmth in darkness and total fog with amazing accuracy. Hoof prints hours old will display a “heat signature” on the ground, and there’s nothing like the warmth of fresh manure in the camera frame to tell you you’re on the right path. If your horse is loose in unfamiliar territory ask the responding Department if they have a thermal imaging camera. With luck, one of these \$20,000 cameras will be available if your horse is lost or injured in the dark or where visibility is minimal.

Tips for getting your horse Rescue Ready:

Train your horse to accept straps draped over its back and down between its hind legs and front legs. Using the large bones and muscles provide the best support for pulling efficiency. Standard automobile tow straps or lengths of attack line fire hose are excellent material to wrap around a horse in the event one needs to be dragged. Its width will keep from cutting into the horse and provide better square inch to pound pulling ratio. Dragging with hose or webbing draped down over the horses back and then run between the front or hind legs gives the best pulling advantage.

“Hooves are not handles” is another icon to remember. In some circumstances the lower legs are wrapped and the hooves hobbled to prevent further injury to the horse and possibly the responders, but they should never be used to drag an animal. With this in mind, ensure your horse is used to having its legs wrapped, and especially to the sound of Velcro and ripping duct tape. Duct tape is a standard on every fire squad truck. Towels wrapped around a horse’s leg and secured with duct tape might be the only protection available from a rural rescue unit. NOTE: a horse that is well accustomed to the everyday sounds of Velcro and duct tape may still react negatively when under the effects of sedation.

Familiarize your horse with the smell of roofing tar paper and the sound of its rustling. Strange as it sounds this material can provide instant traction if your horse is down or trapped on a slippery surface such as shallow ice, polished cement, or large culverts and water ducts. Once an animal is standing make sure a path has been created with the tar paper to ensure the route of safety.

Teach your horses to not be afraid of the light from a flashlight at their feet or anywhere near them. Instinct tells horses that the moving light and shadows is a predator. The fact that there is no scent or sound with the moving shadow further confuses and panics most animals, especially alpha mares and mares with foals. Night rescues are often hampered by horses that interpret the light from a rescuers flashlight as something that is chasing or ready to attack them. Realize too, few first responders will have a clue that this may be terrifying to your horse until it’s too late. Additionally, few responders, or owners for that matter, will try to catch a horse in total darkness.

Teaching your horses to stand while tied, relaxed while blind folded, and to be led from either side, will also help in emergency and evacuation situations. A long sleeved shirt draped over your horses eyes with the sleeves wound around the halter by the

ears provides good protection to the eyes from dust, sand, debris, and smoke. Ideally it should be long enough to cover down over the nostrils to further help prevent damage from toxic smoke or fumes in the event of a hostile air environment.

A willingness and ability to be lead two at a time is another skill your horse should know to be the ultimate in rescue ready. Two horses are generally more comfortable together than one horse by himself. Note that responders will rarely know your horse is more comfortable when lead from the left. Comfort being led from both sides not only helps when leading two horses; it also develops a more balanced horse to ride or drive, which is an added benefit for the rescue ready equine.

Tips for Owners:

Preparation at home, on the road, and before an emergency happens is key. Pre-program ICE (In Case of Emergency) numbers into your phones and have them posted in strategic places in your trucks, trailers, and near entrances to your farm and buildings. These can be also be coded onto your mobile phone as ICE-trailer, ICE-vet, and so on. Responders will look for these numbers in the event you are unconscious or otherwise unavailable to provide this information.

As an additional effort, post in your trailers, trucks, and barns a note "TO EMERGENCY RESPONDERS", which is a signed document stating your wishes in the event a traumatic event occurs to your animals when you cannot be reached. Animals have suffered for hours from fires or beside the road after being hit by cars due to the unavailability of owners to authorize their care or humane euthanasia. A very good sample of this note is available for trailering on line and at no charge from: <http://images.equinetwork.com/usrider/USRider-Emergency-Responder.pdf> If you secure this form, consider adding /farm after "this trailer", and giving a copy to your local fire department or first responder agency. Keep a copy on the dash or visor of your tow vehicle and another copy taped to the inside any doors of your trailer. Make sure the form gives complete contact information for someone who is authorized to make emergency treatment decisions for your animals in case you or your chosen veterinarian is not available.

As owners and caretakers of livestock we have a responsibility to always prepare for their safety. Owners that know a few basics will help responders provide for their horses and other animals during emergency events. Sponsoring training and organizing with local fire departments to provide regional large animal emergency rescue equipment will help reduce response time. And the best you can do to get yourself and your horse rescue ready, enables the best chance of a successful rescue.

NOTICE OF BY-LAW CHANGES

My name is DJ Bradshaw and I am your new American Shire Horse Association Board of Director. I have been serving on the Rules Committee for a couple years now and have taken the lead on some Bylaw changes that the Association needs to vote on. I will present them here for your review and this shall serve as notice of the intent to change the bylaws as described in our bylaws per section Article XV Section 2. Notice. At least thirty days written notice shall be given to all members of intention to alter, amend or repeal or to adopt new bylaws at any such meeting of the members. This will be the first voting that ASHA has done that will be done using electronic voting, that ASHA members approved in 2018. So to that note, please contact the ASHA office @ (888) 302 – 6643 or email at secretary@shirehorse.org to verify we have the correct email address and current information about your membership.

For those that do not have an email address a ballot will be mailed to you for any votes or elections that ASHA will be conducting. We will be conducting a vote on these bylaw changes beginning May 1st, 2020 ending May 16th, 2020. This will be two weeks. Members may vote on these changes if membership is good 6 months prior to the vote. If you are unsure if you are eligible, please contact ASHA as we can help you determine the dates. This would be November 1st, 2019 to qualify for this voting on bylaw changes.

Annual Meeting. The purpose of these bylaw changes is to allow ASHA to have more flexibility to hold the Annual Meeting of the Members at other times of the year. The first section will state what is currently in the bylaws and then the next section is what ASHA is proposing as a bylaw change to allow for comparison and contrast. **Strike through words are to be removed, italic bold words are the new additions.**

Current ASHA Bylaws state... Section 1. Annual Meeting. An annual meeting of the members shall be held no later than the last day of February in each year, for the purpose of the transaction of such business as may come before the meeting. The date and time of the annual meeting shall be fixed by the board of directors.

Proposed ASHA Bylaws change... Section 1. Annual Meeting. An annual meeting of the members shall be held no later than the last day of **February** *October* in each year, for the purpose of the transaction of such business as may come before the meeting. The date and time of the annual meeting shall be fixed by the board of directors. ***No annual meeting shall be held in the months of November nor December.***

Current ASHA Bylaws state... Section 5. Action by Members by Mail Election. Any action required by law to be taken at a meeting of the members, or any action which may be taken at a meeting of members, may be taken without a meeting if submitted to, and approved by, the members by election by mail. Such election shall be conducted in accordance with Article XVI of these bylaws. Where directors or officers are to be elected by members, such election shall be conducted by mail in accordance with Article XVI of these bylaws.

Proposed ASHA Bylaws change... Part 1 - Section 5. Action by Members by Mail Election: ~~Any action required by law to be taken at a meeting of the members, or any action which may be taken at a meeting of members, may be taken without a meeting if submitted to, and approved by, the members by election by mail.~~ ***Any action required to be taken at a meeting of the members, or any action which needs to be taken by the members, may be taken without a meeting if submitted to and approved by the members by mail or electronic means.***

Part 2 - Such ~~election~~ ***action*** shall be conducted in accordance with Article XVI of these bylaws. Where directors or officers are to be elected by members, such election shall be conducted by mail or ***electronic means*** in accordance with Article XVI of these bylaws. (This change needs to be made to be in compliance with Article XVI which was voted on and approved December 2018 for allowing electronic voting.) A **YES** vote is asked to make bylaws correct.

Amending the Bylaws. This change is needed to again come into compliance with Article XVI of ASHA bylaws.

Current ASHA Bylaws state... ARTICLE XV. AMENDMENTS TO BYLAWS

Section 1. General. These bylaws may be altered, amended or repealed and new bylaws may be adopted by a majority of the members present in person or by proxy at any regular meeting or at any special meeting of the members at which a quorum is present, or by the affirmative vote of a majority of those members returning their ballots in a mail election held in accordance with Article XVI of these bylaws.

Proposed ASHA Bylaws change... Section 1. General. These bylaws may be altered, amended or repealed and new bylaws may be adopted by a majority of the members present in person or by proxy at any regular meeting or at any special meeting of the members at which a quorum is present, or by the affirmative vote of a majority of those members returning their ballot ~~in a mail election~~ held in accordance with Article XVI of these bylaws.

ASHA Board of Directors would also like to present a change in the way and terms Directors are elected. Currently ASHA has a block of 4 and 5 directors that are elected for 4 year terms with elections every other year in even years. The Board feels that shifting to a system that allows 3 Directors to be elected every year to serve 3 year terms. This would hopefully make it easier for more members to consider running for the Board and not be committed to such a long term to serve. The current bylaw is first and the proposed changes second.

Current ASHA Bylaws states... ARTICLE V. BOARD OF DIRECTORS

Section 2. Number, Tenure and Qualifications. The number of directors shall be nine. The directors shall hold office un-

til the beginning of the annual meeting of the board of directors following the election at which their successors shall have been elected and qualified. Directors need not be residents of the State of Washington but must be Regular members of the Association. Directors shall be elected for terms of four years, and may not serve more than two consecutive terms. The election of directors shall be staggered so that four or five directors shall be elected during November of each even-numbered year, as appropriate, to take office at the beginning of the annual meeting of the board of directors in the following odd-numbered year. A member who has served two consecutive terms as a director shall be ineligible for re-election to the board of directors until the next even-numbered year following the end of the member's second consecutive term as director. A director may not hold the position of secretary of the Association during their tenure as a director.

Proposed ASHA Bylaws change... Section 2. Number, Tenure and Qualifications. The number of directors shall be nine. The directors shall hold office until the beginning of the **first quarter meeting** of the board of directors following the election at which their successors shall have been elected and qualified. Directors need not be residents of the State of Washington but must be Regular members of the Association. **Directors shall be elected for terms of three years, and may not serve more than two consecutive terms. The election of directors shall be staggered so that three directors shall be elected during November of each year and to take office at the beginning of the first quarter meeting of the board of directors of the following year. A member may serve two consecutive terms but will be ineligible for re-election or appointment to fill a vacant position as director for one year. A director may not hold the position of secretary of the Association during their tenure as a director.**

And to be added if Section 2 changes are approved by the membership... **Section 3. Transition Period. In order to effect the change in the length of the terms of Directors and annual election of three Directors, the election of Directors in the years 2020, 2021, and 2022 shall take place as outlined in this Section. In the 2020 election, with five positions open, the members shall elect three Directors for three-year terms and two Directors for one-year terms. The Directors elected to one-year terms shall be eligible to serve two additional three-year terms. In the 2021 election, with two positions open, the members shall elect two directors for three-year terms. In the 2022 election, with four positions open, the members shall elect three Directors for three-year terms and one director for a two-year term. This Section of the bylaws may be removed following the 2022 election without a vote of the membership.**

With changes to Article VI. Officers. Section 2. Election, Eligibility, and Term of Office. The president, vice president and treasurer shall be elected biennially by the board of directors at the regular annual meeting of the board of directors in odd-numbered years. The secretary shall be appointed annually by the board of directors at the regular annual meeting of the board of directors. Additional offices may be created and filled or terminated at any meeting of the board of directors. The officers shall be elected from among the board of directors, except that the secretary need not be a member and shall not be a director. Assistant secretaries and assistant treasurers shall not be required to be directors or members of the Association. Officers shall hold office until their successors shall have been duly elected and shall have qualified, unless their offices are sooner terminated by the board of directors.

Section 2. Election, Eligibility, and Term of Office. The president, vice president and treasurer shall be elected biennially by the board of directors at the **first quarter meeting of the board of directors each year.** The secretary shall be appointed annually by the board of directors at the regular annual meeting of the board of directors. Additional offices may be created and filled or terminated at any meeting of the board of directors. The officers shall be elected from among the board of directors, except that the secretary need not be a member and shall not be a director. Assistant secretaries and assistant treasurers shall not be required to be directors or members of the Association. Officers shall hold office until their successors shall have been duly elected and shall have qualified, unless their offices are sooner terminated by the board of directors.
